In order to review the above-referenced *Joint Application*, the Tennessee Regulatory Authority ("TRA" or "Authority") requires additional information. Please provide the information requested below by April 3, 2014, and refer to this correspondence as Data Request No. 1 in the response.

1. Have the Applicants have filed a similar application or notice in other states. If so, provide a listing of states and action taken.
2. How many customers are currently served by U.S. Telecom Long Distance, Inc. ("USTLD") in Tennessee?
3. Has the customer notification letter provided as Exhibit B been sent to USTLD customers? If so, on what date was the letter sent to USTLD customers?
4. Provide a copy of the customer notification letter that (a) is on letterhead consistent with TRA Rule 1220-4-2-.56(2)(d)(2); (b) includes language consistent with TRA Rule 1220-4-2-.56(2)(d)(4) and (c) indicates that unless the customer selects and telecommunications service provider, the customer' local or long distance service will be transferred to the

acquiring telecommunications provider as required by TRA Rule 1220-4-2-.56(2)(d)(2).

5. Provide a copy of the envelope used to send the customer notification letter.
6. Provide a copy of the self certification letter filed with the FCC in CC Docket 00-257 concerning transfers of customer base.
