I am in receipt of the Notice to Appear for Hearing dated August 1, 2014 in the above-referenced matter. I represent the company, so kindly address all future correspondence in this matter to my attention.

My client was previously scheduled to be out of the Country on the hearing date, September 15, 2014, on his honeymoon. His wedding ceremony is on September 12, 2014 and the bride and groom will depart for their honeymoon shortly thereafter.
