On April 1, 2014, the Tennessee Regulatory Authority ("TRA") received the application of TelexFREE, LLC to provide resold interexchange telecommunications services in Tennessee, as filed by ISG Telecom Consulting ("ISG").

On April 22, 2014, the TRA received a letter from ISG Telecom Consulting, indicating the firm would no longer be representing TelexFREE, LLC due to allegations that TelexFREE, LLC had provided false and misleading information to ISG, and that TelexFREE, LLC is currently under investigation by the State of Massachusetts and the United States Securities and Exchange Commission. The letter further indicated that all future correspondence about this filing should be directed to Mr. Jim Merrill.
