This letter is to inform you that the *Application of TelexFREE, LLC*, for authority to Resell Telecommunications Services in Tennessee, as revised, filed with the Tennessee Regulatory Authority ("Authority") on March 25, 2014 and March 28, 2014, respectively, remains incomplete. Following receipt of ISG Telecom Consulting's letter, dated April 18, 2014, withdrawing as TelexFREE, LLC's consultant, the Authority sent by certified mail a request for certain information to Mr. Jim Merrill, TelexFREE, LLC, President and Managing Member.
