Pursuant to Ordering Paragraph No. 6 of the Commission's Order dated May 8, 2014 in Case No. PUE 2014-00031, Kentucky Utilities Company d/b/a Old Dominion Power Company ("KU/ODP") hereby files an original and three (3) copies of information related to issuances under said order.

On September 28, 2015 KU/ODP issued \$500 million of First Mortgage Bonds in accordance with the aforementioned order. The details of the bond issuance are shown below.

A total of \$14,076,899 will be amortized over the life of the 10 year bonds and a total of \$29,611,403 will be amortized over the life of the 30 year bonds. Including the amortization of the swaps, amortization of the discount, and the amortization of the underwriting commissions the all in yield on the 10 year bonds will be 4.08% and the all in yield on the 30 year bonds will be 5.22%. KU/ODP entered into these hedging agreements in order to lock in treasury rates from the date of the swap issuance until the bond issuance date when all swap agreements were terminated.

Bond issuance expenses billed to date, other than commissions, total \$514,622. Additional issuance expenses are anticipated to be paid subsequent to the date of this filing. As of the issuance date, a total of \$500 million of debt had been issued and no debt remained available to be issued under the authority granted in Case No. PUE-2014-00031.
