Re: Failure to File Semi-Annual Reports, Docket No. 14-00036

Dear Ms. Dillon:

Pursuant to the Tennessee Regulatory Authority's ("TRA") May 5th, 2015 Order in Docket No. 14-00036, Plains and Eastern Clean Line LLC is required to file "semi-annual reports with [TRA] beginning on July 1, 2015, regarding the overall status of the Plains & Eastern Project in Tennessee, including any agreements with investors, interconnection agreements with the Tennessee Valley Authority, easement with property owners, and any modifications in the route as filed with the *Petition*." See Order p. 8.

As of January 15, 2018, Plains and Eastern Clean Line, LLC has failed to file the most recent semi-annual report, or the same has not been uploaded to the TRA's online docket room. The reports are critical to ensure the TRA and the general public are apprised of the Project's status. To illustrate, we understand that Plains and Eastern Clean Line, LLC has taken the following actions concerning the Project since December 1, 2017:

- Withdrawn its request for interconnection with the Tennessee Valley Authority at a connection point in Shelby County, Tennessee;
- Withdrawn its request for interconnection with the Mid-Continent Independent System Operator at a connection point in Pope County, Arkansas; and,
- Disposed of its interest in Plains and Eastern Clean Line Oklahoma, LLC, including all of that entity's assets (primarily rights-of-way) located in the State of Oklahoma.


On behalf of several interested parties in the State of Arkansas, many who participated directly in Docket No. 14-00036, we respectfully request a status update on the TRA's Order and whether the above-described actions impact, in any way, the TRA's authorizations and approvals.
