Please accept this letter as IntelePeer, Inc.'s request to change its corporate name to Airus, Inc. IntelePeer, Inc. is authorized to provide local exchange telecommunications services and intrastate interexchange services pursuant to authority granted by the Commission in Docket No. 09-00201 and elected market-based regulation on May 3, 2011. This name change is not an element of a larger transaction. No changes have been made to the Company's corporate organization or ownership. Moreover, the change of the Company's name does not affect the rates, terms and conditions under which IntelePeer's customers would receive service. Importantly, IntelePeer currently does not have end user communications customers in Tennessee. Therefore, no notice letter has been drafted. The Company requests that its authorization in Tennessee be reissued or otherwise revised to reflect its new name.

Airus is a Delaware corporation, registered with the Tennessee Secretary of State to transact business as a foreign corporation. A copy of the Company's amended formation documents is appended as Attachment 1. A copy of the Company's amended foreign corporate qualification document is provided in Attachment 1.
