Tennessee Wastewater Systems, Inc. ("TWSI" or "Respondent") shall appear before the Tennessee Regulatory Authority ("Authority") at **9:00 a.m. CDT on June 10, 2014**, and show cause, if there be any, why the Authority should not proceed to take action against TWSI for the unlawful actions and omissions alleged against it in the above referenced docket, including, but not limited to, revoking the amendment to its Certificate of Public Convenience and Necessity ("CCN") to serve The Villages at Norris Lake in Campbell County, Tennessee, issued on April 11, 2007 in TRA Docket No. 06-00277, and imposing civil penalties and sanctions for failure to provide service to the area within two years of receiving authorization to do so in violation of TRA Rule 1220-4-13-.06; failure to prohibit the title to physical assets of a wastewater system from being subject to liens or judgments in violation of TRA Rule 1220-04-13-.10(1); failure to file a request for alternative financial security and failure to have the full amount of the bond in place pending approval of that request for the years 2012 and 2013 in violation of TRA Rule 1220-04-13-07(5); and for being unwilling and incapable of providing wastewater service to The Villages at Norris Lake in violation of TRA Rule 1220-04-13-.09.

This matter will be held in Hearing Room G.201 on the Ground Floor of the Andrew Jackson State Office Building located at **500 Deaderick Street**, **Nashville**, **Tennessee**, and conducted by the voting panel assigned to this docket, Chairman James M. Allison, Director Kenneth C. Hill, and Director David Jones, in accordance with the Tennessee Uniform Administrative Procedures Act, Tenn. Code Ann. § 4-5-101 et seq. Failure to appear may constitute default and result in adverse action against Respondent, including entry of an Order that may be used to seek additional relief in any court of competent jurisdiction. Any party is entitled to be represented by counsel at its own expense.

Any motion to continue or reschedule the date of this hearing must be made in writing and filed with the Office of the Authority Chairman *on or before* June 4, 2014.
