**AGREED MOTION TO REMOVE "CONFIDENTIAL" DESIGNATION**

Tennessee Wastewater Systems, Inc. ("TWSI") asks that the deposition and exhibits of Frank Wallace, general manager of the Caryville-Jacksboro Utility Commission ("CJUC"), be made public documents and that the "confidential" designation be removed. Mr. Shiva Bozarth, counsel for the Party Staff, states that he does not object to this request.

Counsel for TWSI makes this request after talking to Mr. Don Scholes, counsel for CJUC, who stated that CJUC does not oppose the filing of these documents as public records.


Therefore, TWSI asks that Mr. Wallace's deposition and exhibit no longer be considered as confidential and that the documents be made matter of public record pursuant to paragraph 12 of the "Protective Order" issued May 29, 2014, in this docket.<sup>1</sup>

<sup>1</sup> Since there is no dispute that these documents should no longer be kept confidential, TWSI asks that the requirement in paragraph 12 that a motion to "contest" the confidential designation of a document be filed fifteen days prior to the Hearing on the Merits be waived. No one "contests" making these documents public.
