Furthermore, all federal high-cost support, including high cost loop support, local switching support, high-cost support received pursuant to the purchase of exchanges, high-cost model support, and hold harmless support, will be used only for the provision, maintenance, and upgrading of facilities and services for which the support is intended, consistent with 47 U.S.C. § 254(e) of the Telecommunications Act of 1996.


The Company received \$1,052,745 in Universal Service Funds for the 2013 fiscal year,

High Cost Loop	\$ 42,414
Local Switching Support	\$ 2,954
Interstate Common Line Support	\$ 635,609
Connect America Fund	\$ 371,768

The Company allocated \$1,226,711 to provisioning and maintenance and \$160,379 to upgrading of facilities and services for which the support was intended, consistent with 47 U.S.C. § 254(e) of the Telecommunications Act of 1996.
