MOTION OF INTEGRATED RESOURCE MANAGEMENT, INC. TO WITHDRAW PETITION AND DEFER FURTHER PROCEEDINGS

("IRM") respectfully moves the Authority to withdraw its petition scheduled for hearing on Friday, October 10, 2014, or in the alternative, to hold the hearing in abeyance until November 1, 2014 pending the result of the IRM application for a letter of credit. In support of its motion, IRM would show to Authority as follows:

- IRM is in the process of making application for replacement financial security in an amount of \$120,000.00 in the form of letter of credit. According to the authorized officer at Peoples Bank, the letter of credit is expected to be issued on or before October 31, 2014. A letter from the bank addressed to the Authority confirms this expectation and is attached hereto and incorporated herein by reference.
- 2. The anticipated replacement security in the amount of the \$108,000.00 required pursuant to Authority rule and will render the Petition moot.
- 3. Under the circumstances, it appears there will be no need for a hearing of the nature described in the original petition.
- 4. A delay of 21 days will not prejudice any rights or obligations of IRM or the Authority.

For the foregoing reasons, IRM requests that the Petition filed in this cause be withdrawn, or in the alternative, placed in abeyance for the purpose of allowing sufficient time for IRM to procure sufficient security or proceed on another course of final disposition of the issues.


