Attached, please find a copy of LOC No. 1416484 issued by Peoples Bank on October 31, 2014 in the amount of \$110,000.00; Tennessee Regulatory Authority beneficiary. Previously, we had discussed a LOC in the amount of \$120,000.00 but the additional \$10K was used to cover the expense associated with the LOC. I would assume this LOC is sufficient since the TRA's current requirement is \$108K. It is my understanding that the original LOC has been mailed to the TRA and it should be in receipt of same shortly.
