- 3. Atmos serves approximately 132,000 residential, commercial, and industrial customers in Tennessee. Among the areas served is the City of Johnson City, Tennessee.
- 4. Atmos currently provides natural gas service to the City of Johnson City pursuant to a franchise agreement incorporated into City Ordinance No. 3869-03 (the "Ordinance"), dated July 17, 2003.
 - 5. That franchise agreement will expire by its terms on July 17, 2028.
- 6. The existing franchise agreement was approved by this Authority in 2003 in Docket No. 03-00520. The franchise agreement allows, subject to the approval of the Tennessee Regulatory Authority, for annual modification of the franchise fee at the election of the City. The City invoked its rights under this provision and negotiations ensued. These negotiations recently concluded and a new Resolution (the "Resolution") was submitted by the City of Johnson City and adopted on July 17, 2014. A true and correct copy of this Resolution is attached hereto as Exhibit 1.

- 7. In accordance with the terms of the Ordinance and the Resolution, the modified franchise fee will become effective upon election by the City of Johnson City and final approval by the Tennessee Regulatory Authority.
- 8. The modified franchise fee with the City of Johnson City is necessary and proper for the public convenience and properly conserves the public interest. Pursuant to Tennessee Code Annotated § 65-4-105(e), the franchise fee will, insofar as practicable, be billed pro rata to the utility customers receiving service within the municipality.

WHEREFORE, Atmos respectfully requests that the Authority approve the modified franchise fee with the City of Johnson City attached hereto as Exhibit 1 pursuant to Tennessee Code Annotated § 65-4-107.

A RESOLUTION APPROVING NEGOTIATIONS BETWEEN ATMOS ENERGY AND THE CITY OF JOHNSON CITY RESULTING IN AN INCREASE IN THE FRANCHISE FEE FROM THREE PERCENT TO FIVE PERCENT OF THE ANNUAL GROSS REVENUE OF NATURAL GAS SALES MADE, BILLED AND COLLECTED BY ATMOS ENERGY ON ALL CLASSES OF CUSTOMERS WHO ARE LOCATED WITHIN THE CITY LIMITS AND AUTHORIZING THE PETITIONING OF THE TENNESSEE REGULATORY AUTHORITY FOR APPROVAL OF THE FIVE PERCENT FRANCHISE FEE

WHEREAS, Ordinance #3869-03, which amended Ordinance #2726 and Ordinance #3511, granted to United Cities Gas Company and its successors and assigns certain franchise rights and authorized (but did not require) the City of Johnson City and ATMOS Energy to negotiate franchise fees on a annual basis, subject to the approval of the Tennessee Regulatory Authority; and

WHEREAS, the City of Johnson City and ATMOS Energy have concluded negotiations, resulting in an increase from three percent (3%) to five percent (5%) of the franchise fee; and

WHEREAS, ATMOS Energy or its successors and assigns has agreed to petition the Tennessee Regulatory Authority for approval of the five percent (5%) franchise fee arrived at between the parties.

NOW, THEREFORE, BE IT RESOLVED that a five percent (5%) franchise fee has been produced by negotiations between the City of Johnson City and ATMOS Energy and is acceptable to both parties, and both parties agree that ATMOS Energy shall take immediate steps to present this resolution to and seek the approval of the Tennessee Regulatory Authority for the five percent (5%) franchise fee.

BE IT FURTHER RESOLVED that ATMOS Energy indicates its acceptance of the terms of this resolution pursuant to the following:
