PETITION TO ADOPT STATUTORY ANNUAL REVIEW OF RATES AND TARIFF WITH PROCEDURES FOR STATUTORY ANNUAL RATE REVIEW

Atmos Energy Corporation respectfully files this Petition to opt into the statutory annual rate review procedure established under Tennessee Code Annotated Section 65-5-103(d)(6). Pursuant to Section 65-5-103(d)(6)(C), Atmos Energy petitions to have the Authority adjust the Company's tariff rates annually such that they are sufficient to enable the Company to earn the authorized return on equity established in its last rate case, with the new rates to take effect January 1, 2015, and each January 1 thereafter. To provide for an orderly annual review pursuant to the statute, the Company has filed a proposed tariff to implement procedures for the statutory annual review, and Atmos Energy also respectfully petitions to adopt this tariff, with any amendments the Authority may order.

- 3. Atmos Energy's Kentucky/Mid-States Division serves customers in Tennessee, Kentucky and Virginia. Atmos Energy serves approximately 132,000 residential, commercial, and industrial customers in Tennessee. The Company has a Tennessee-based work force of slightly less than 160 employees including 32 employees in the Kentucky/Mid-States division office in Cool Springs. The Atmos Energy utility plant in Tennessee includes approximately 3,400 miles of transmission and distribution lines.
- 4. Tennessee Code Annotated Section 65-5-103(d)(6) gives utilities a statutory right to opt for an annual review of their rates. Under subsection (d)(6)(B), a utility is eligible to opt for annual rate review if the utility "has engaged in a general rate case" within the past five years. Atmos Energy engaged in a general rate case less than five years ago, in Docket No. 12-00064, and is therefore eligible to opt for annual rate review under the statute. The final order in Docket No. 12-00064 was entered on December 4, 2012, and approved, *inter alia*, a return on equity of 10.1%.

- 5. Upon a utility's election to participate in the statutory annual rate review mechanism of subsection (d)(6), the statute provides in subsection (d)(6)(C) that the Authority "shall review the annual filing by the public utility within one hundred twenty (120) days of receipt and order the public utility to make the adjustments to its tariff rates to provide that the public utility earns the authorized return on equity established in the public utility's most recent general rate case."
- 6. Atmos Energy's existing rates for natural gas service are not adequate to permit it an opportunity to recover its reasonable operating costs and to earn its allowed rate of return on equity as established in Docket No. 12-00064. Although Atmos Energy operates very efficiently, it is not achieving its allowed return on capital with the rates currently in place. The Company's indicated return on equity for the Forward Looking Test Year is 8.87%. Such return falls below the allowed return on equity of 10.1% approved for the Company in Docket No. 12-00064.
- 7. Pursuant to Tennessee Code Annotated section 65-5-103(d)(6)(C), Atmos Energy respectfully petitions for the Authority to adjust the Company's tariff rates effective January 1, 2015, sufficient to enable Atmos Energy to earn the return on equity of 10.1% established in Docket No. 12-00064. The Company has filed eleven schedules supporting and calculating the necessary rate increase to the Company's tariff rates beginning January 1, 2015. These schedules are attached hereto as Schedules 1 through 11.
- 8. Pursuant to the annual mechanism established in section 65-5-103(d)(6), Atmos Energy respectfully petitions that its tariff rates be adjusted annually effective each January 1 to a level sufficient to allow the Company to earn its authorized return on equity, with all tariff rates to be adjusted in proportion to the relative base revenue share of each, as approved in the

Company's most recent general rate case.

- To allow for an orderly implementation of the annual review mechanism 9. established by Section 65-5-103(d)(6), Atmos Energy has drafted a proposed Annual Review Mechanism ("ARM") tariff setting forth a timetable for the Company's annual filings, and specifying the documentation that Atmos Energy will file annually. The proposed tariff is attached as an exhibit to the testimony of witness Gregory K. Waller. The ARM tariff calls for the company to make its annual ARM filing no later than September 1 of each year. The tariff specifies that the Company's annual filing will use a historic base period defined as the twelve month period ending June 30 of each calendar year, and a forward looking test year defined as the twelve months beginning January 1 of each calendar year following the September 1 filing. The first historic base period ends June 30, 2014, and the first test year begins January 1, 2015. The tariff provides that the annual ARM filing will include 11 specified schedules that cover Cost of Service, Summary of Revenues at Present Rates, Cost of Gas, Operation and Maintenance Expense, Taxes Other Than Income, Depreciation and Amortization Expenses, Rate Base and Return, Computation of State Excise and Income Taxes, Overall Cost of Capital, Rate of Return, and Proof of Revenues and Calculation of Rates. The Company has filed these schedules supporting the January 1, 2015 rate adjustment, and they are attached hereto as Schedules 1 through 11. Atmos Energy respectfully petitions for approval of its proposed Annual Review Mechanism tariff, with any amendments that the Authority may order.

WHEREFORE, Atmos Energy respectfully petitions for the following relief:

- 1. That Notice be issued and a hearing set regarding this Petition;
- 2. That, pursuant to Tennessee Code Annotated section 65-5-103(d)(6)(C), the Authority order Atmos Energy to make adjustment to the Company's tariff rates sufficient to enable the Company to earn the authorized return on equity of 10.1%, with the new rates to take effect January 1, 2015.
- 3. That, pursuant to the same statutory provision, the Authority similarly adjust the Company's tariff rates annually effective January 1 of each succeeding year, unless and until the

annual review plan may be terminated pursuant to Tennessee Code Annotated section 65-5-103(d)(6)(D).

- 4. That the Authority approve the Company's proposed Annual Review Mechanism tariff, with any amendments that the Authority may order; and
 - 5. That Atmos Energy be granted such other relief as may be warranted.
