Dear Mr. Taylor:

On February 27, 2015, Piedmont Natural Gas, Inc. ("Piedmont") filed a Revised Rate Schedule 342 along with a Revised Rate Schedule 343 and a Revised Rate Sheet in the above referenced docket. That filing discontinued Rate Schedule 342 in its entirety. On March 11, 2015, the Tennessee Fuel and Convenience Store Association ("TFCA") filed a letter requesting that Piedmont clarify that its February 27 filing of Rate Schedule 342 was wholly consistent with the Tennessee Regulatory Authority's (the "Authority") ruling on February 9, 2015 that provided that Piedmont's Rate Schedule 342 be discontinued. After discussion with TRA Staff, attached to this letter is Piedmont's Rate Schedule 342 showing and clarifying that it has been discontinued in full, consistent with the Authority's February 9 ruling.
