Chuck,

The target date for the hearing is September 14, with a final cut-off for all preliminary matters by September 3. Despite the relatively late request and entry into the proceedings, Summit View was granted intervention on the premise that doing so would not delay the proceedings. I will allow Summit View a brief extension of time to file its testimony and move back the responsive testimony as follows:

August 7 - Summit View Pre-Filed Direct Testimony  
August 12 - Consumer Advocate Statement/Supplemental Testimony (if any)  
August 19 - Utility Pre-Filed Rebuttal  
\*The rest of the schedule will remain unchanged.

Kelly,

I have spoken with Henry and he has no objection to an extension to next Friday, August 7<sup>th</sup>. I spoke briefly to Rachel but she did not have time to talk. I did indicate to her the purpose of my call and she said she would get back to me. I have not heard from her yet.

I suspect the other parties will need a couple of weeks to respond to our filing but that should not be much of a problem assuming the hearing will not be until sometime in September. We are trying to get an independent 3<sup>rd</sup> party expert to do an analysis of the problems with the Summit View system and provide alternative remedial action and cost estimates. I feel it would be helpful to all of the parties to understand the problems and possible fix.

Although I appreciate Henry's offer of a week, I don't see that there would be any delay by pushing that date out until August 14<sup>th</sup>. Please let me advise. Thank you.
