**ORDER ESTABLISHING PROCEDURAL SCHEDULE**

This matter came before the Hearing Officer of the Tennessee Regulatory Authority (“Authority” or “TRA”) during a Status Conference held on March 9, 2015, with Tennessee Wastewater Systems, Inc. (“TWSI”) and the Consumer Advocate and Protection Division of the Office of the Tennessee Attorney General (“Consumer Advocate”) (collectively, the “Parties”). The purpose of the Status Conference was to discuss the issues to be considered by the Authority and to establish a procedural schedule for the orderly administration of these proceedings.

On March 6, 2015, the Parties emailed a proposed procedural schedule for the Hearing Officer’s consideration. The proposal contemplates the completion of all pre-hearing filings by the end of May, 2015 and a target hearing date before the Authority panel in June, 2015. After discussing the proposal and considering the preferences of the parties, the Hearing Officer hereby establishes the Procedural Schedule set forth in **Exhibit A** attached to this Order.
