
On October 21, 2015, the Tennessee Public Utility Commission ("TPUC") issued a certificate of franchise authority to Google Fiber Tennessee, LLC ("Google Fiber") to provide video services to the City of Belle Meade, City of Berry Hill, City of Forest Hills, and City of Oak Hill ("Satellite Cities"). Previously, the TPUC had issued a certificate to Google Fiber to provide video services to the Metropolitan Government of Nashville and Davidson County ("Metropolitan Nashville"), except the Satellite Cities.

Google Fiber has been actively building out its network and providing services in Metropolitan Nashville. However, because of construction delays and the difficulty of building from scratch a countywide, state-of-the-art fiber optics network, Google Fiber has not been able to expand to the Satellite Cities as quickly as planned. Additionally, the implementation of Metro Nashville's well-crafted One Touch Make Ready ordinance to improve construction efficiency and safety has been delayed by the subsequent lawsuit related to that ordinance.

Google Fiber intends to amend its certificate of franchise authority in the future to re-include the Satellite Cities. Google Fiber is committed to continuing to explore innovative deployment methods and providing its Internet service to the Satellite Cities as soon as practicable.

Google Fiber regrets the delay in beginning service in the Satellite Cities. If you have any questions concerning this matter, please do not hesitate to contact Google Fiber.
