ORDER AMENDING PROCEDURAL SCHEDULE

This matter came before the Hearing Officer of the Tennessee Regulatory Authority ("Authority" or "TRA") during a Status Conference held on March 9, 2015 with Atmos Energy Corporation ("Atmos") and the Consumer Advocate and Protection Division of the Tennessee Attorney General ("Consumer Advocate" or "CAPD") (together, the "Parties") to establish a procedural schedule for the Alternative Rate Review Mechanism ("ARM") reinstated to Atmos' *Petition* on February 18, 2015. The goal and design of any procedural schedule is to efficiently move the proceedings forward to a hearing and final conclusion on the merits. Nevertheless, a procedural schedule's effectiveness directly depends on cooperation by the parties in meeting the individual benchmark dates.

On January 12, 2015, the Hearing Officer issued a procedural schedule in this matter for the general rate case portion of Atmos' *Petition*. On March 4, 2015, the Parties emailed the Hearing Officer a proposed procedural schedule that included both the general rate case and the ARM. After considering the preferences of the parties discussed during the Status Conference, the Hearing Officer hereby establishes the Procedural Schedule set forth in Exhibit A attached to

this Order. In addition, the Hearing Officer reminds the Parties that Rebuttal Testimony should be limited only to issues raised in the Consumer Advocate's Direct Testimony and requests that Atmos' Rebuttal Testimony include the page and line number of the Consumer Advocate's testimony that is being rebutted.
