RE: Docket No. 14-00169, Application of New Horizons Communications Corp. for a Certificate of Convenience and Necessity to Provide Competing Local Exchange, Exchange Users, and Interexchange Telecommunications Service in Tennessee

Dear Chairman Hilliard:

Petitioner New Horizons Communications Corp. ("NHC"), through its undersigned attorney, responds to the Tennessee Regulatory Authority's ("TRA") May 5, 2015 Information Request in the above-referenced Docket that was issued by David Foster, Utilities Division Chief ("TRA Staff"):

Question 1: Please provide a notarized statement from an officer of New Horizons indicating whether or not the company is providing voice telecommunications service in Tennessee.

Response: The notarized statement of Mr. Glen Nelson is attached.

Question 2: If New Horizons is providing voice telecommunications services in Tennessee, please state New Horizons's position on how providing telecommunications services in Tennessee is not a violation of Tenn. Code Ann. § 65-4-201 (b), § 65-4-125 (j) and Tenn. Comp. R. and Regs 1220-4-8-.02.

Response: As explained in Mr. Nelson's sworn statement attached hereto, NHC has a resale agreement with a CLEC that is certified nationwide under which NHC can resell local exchange services in states where it is certified to provide such services. NHC just discovered that it inadvertently processed certain orders with this CLEC to resell six (6) lines in Knox County, Tennessee. These lines are six (6) lines out of tens of thousands of POTs lines NHC has nationwide that NHC erroneously processed. Upon request by TRA Staff, NHC will transfer these six (6) lines to another carrier. With exception of these six (6) lines, NHC is not providing voice telecommunications in Tennessee.

Question 3: If New Horizons is not providing voice telecommunications services in Tennessee, and it is outsourcing 100% of its regulatory compliance to CSI, explain why Compliance Solutions, Inc. submitted both a UD-16 form on March 31, 2015 to the Tennessee Regulatory Authority indicating that New Horizons had intrastate revenue for 2014 and a Wireline Activity Report on April 30, 2015, indicating New Horizons was providing 6 switched voice grade equivalent access lines in Knox County, Tennessee for the month ending March 31, 2015.

Response: As indicated above, because the April 30, 2015 Wireline Activity Report filing reflects 6 resold lines that NHC inadvertently processed, the filing is correct.

In responding to this Information Request, NHC would like to bring to TRA Staff's attention that since 2011, NHC has had an A+ rating from the Better Business Bureau. See http://www.bbb.org/boston/business-reviews/telecommunication-equipment-and-systems-service-and-repair/new-horizon-communications-in-lexington-ma-112532/. NHC is known as a strong, stable company committed to open business practices and outcomes for all involved. Moreover, for the fourth year in a row, NHC is one of Inc. magazines fastest growing companies. See http://www.inc.com/inc5000/list/. Getting this honorable designation is driven by NHC's intense focus on unparalleled customer service and account management, featuring round-the-clock support, customized solutions and superior products.

NHC wishes to provide a full array of its exceptional services to Tennessee businesses, especially those with other locations outside of the State of Tennessee that are existing NHC customers, so that they have a full range of NHC's services in Tennessee. Such services would extend beyond NHC's VoIP offerings to include, with the TRA's approval, traditional local exchange services, such as POTS lines, to the extent Tennessee business customers would like such alternative services or by necessity, require such services. NHC urges TRA staff to ensure that Tennessee business customers have such alternative options. The ability of NHC to provide a full array of services, which includes local exchange services, will therefore serve the present and future public convenience and necessity. Moreover, NHC's exceptional status in the industry and unparalleled customer service, which are propelled by the exceptional leadership in NHC, demonstrates its sound financial, technical and managerial abilities needed for certification.

For these reasons, NHC respectfully requests that TRA Staff support NHC's certification application. In addition, NHC respectfully requests an opportunity to meet with TRA Staff during the week of May 11, 2015 to discuss NHC's application and how Tennessee businesses would benefit by NHC becoming a certified provider in Tennessee. I will be contacting you in short order to hopefully schedule such a meeting. Thank you.
