



4. During the Hearing, on the record, I administered the testimonial oath to Witness prior to the Witness providing testimony via telephone before the Tennessee Regulatory Authority.


5. I remained physically present with the Witness at all times during the Witness' testimony until such Witness was excused from examination by the Hearing officer.
