



ARTICLES OF INCORPORATION OF ... INFINITY NETWORKS, INC.

ARTICLE L

The name of this corporation is INFINITY NETWORKS, INC.

1

ARTICLE II.

The corporation's purpose is to engage in any lawful activity for which corporations may be formed under the business corporation law of Louisians.

ARTICLE III.

The corporation has authority to issue 100,000 shares of common stock at \$.01 (one cent) par value.

ARTICLE IV.

The corporation shall have at least two but no more than five directors except that when all of the outstanding shares are held of record by fewer than two shareholders than there need be only as many directors as there are shareholders, but this shall not prevent a greater number of directors as aforesaid. The number of directors may be increased or diminished from time to time by amendments to the By-Laws.

ARTICLE V.

The name and address of the incorporator of the corporation are:

ARTICLE VI.

Any director absent from a meeting of the Board of Directors or of any committee thereof may be represented by any other director or shareholder, who may cast the absent director's vote according to his written instructions, general or special.

ARTICLE VII.

. Whenever the affirmative vote of shareholders is required to authorize or constitute corporate action, the consent in writing to such action signed only by shareholders holding that

proportion of the total voting power on the question which is required by law or by these Articles of Incorporation, whichever requirement is higher, shall be sufficient for such action, without necessity for a meeting of shareholders.

ARTICLE VIII.

Shareholders of the corporation shall have preemptive rights. When shares of stock are to be issued, each shareholder shall be given written notice of same, which notice may be waived by written waiver, of the number of shares to be issued and the price of each share as fixed by the Board of Directors. The shareholders shall have a period of ten (10) days after receipt of notice or after written waiver of notice within which to subscribe for such proportions of the shares to be issued as the number of shares held by said shareholders bears to the total number of shares then outstanding. If any shareholder fails to subscribe within the ten (10) day period or waives the right to subscribe in writing, the other shareholders shall succeed to the right to subscribe in the proportions of their respective ownership of the outstanding shares and they shall have an additional ten (10) day period within which to subscribe for such shares. Shares which have been offered to shareholders as set forth above and which have not been subscribed within the prescribed period, or the right to subscribe waived in writing, may, for a period of one year following the end of such period, or one year following written waiver to subscribe, be issued to any other person or persons at a price not less than that at which they were offered to such shareholders.

ARTICLE IX.

- 1. No stock in this corporation shall be transferred unless the stock shall have been first offered for sale to the corporation, and, if the corporation shall fail or refuse to accept the offer, to each of the other stockholders of this corporation. The offeree shall have an option to purchase the stock to be transferred at the following price: At the same price and on the same terms and conditions as the offeror shall have been offered by a third person at arm's length acting in good faith. The offer shall be in writing and shall set forth the price and terms on which the stock is offered. It shall be sent by registered mail to the President and Secretary of the corporation and to each stockholder at the addresses listed on the corporation book. The right to transfer stock shall not exist until the corporation and all existing stockholders either refuse in writing the offer so made, or waive the requirements of an offer in writing, or until they fail for a period of ten (10) days after receipt of the written offer to accept it by complying with the terms therein set forth.
- 2. Should the corporation be unable or unwilling for any reason to exercise its option as granted above, the option may be exercised by such stockholders as desire to exercise it, in the proportion in which these stockholders hold stock in the corporation.
- 3. After the expiration of the option period, no transfer at a price less than has been offered to the corporation and the stockholders, or on terms or conditions varying from those stated in the letter notifying the corporation and the stockholders of a proposal to transfer, shall be valid, until the right shall have been offered to the corporation and the stockholders to

purchase the stock proposed to be transferred at the precise price and on the precise terms and conditions which were offered to or by the stockholder who proposes to transfer his specific

- 4. The stockholders of this corporation may make agreements between themselves relative to the purchase, among themselves, of the stock of this corporation in the event of the death, insanity, retirement or disability of any stockholder, and in the event of a transfer of his stock by donation to the stockholder's spouse and linear descendants. A copy of any such agreement shall be filed with the Secretary of the corporation, and the provisions of any such agreement shall be binding upon the persons who are parties to it and their respective heirs, administrators, legatees, executors and assigns.
- 5. Except as to a transfer on death or a gift of the stock of a stockholder to his spouse or linear descendants, no sale, mortgage, pledge, conveyance, transfer, seizure, donation, sale under legal process or attachment, or by virtue of any pledge or by notification, and no other disposal of stock of any nature whatsoever shall have any effect as related to the corporation of its stockholders, nor shall it be valid in any fashion until the option period provided above shall have expired.

ARTICLE X.

These Articles of Incorporation may be amended in the manner provided in the By-Laws.


