JOINT MOTION TO AMEND PROCEDURAL SCHEDULE

The Consumer Advocate and Protection Division of the Office of the Attorney General (“Consumer Advocate”) and Kingsport Power Company (“Kingsport Power” or “Company”) jointly move to amend the procedural schedule in this Docket 15-00024. The Consumer Advocate and Kingsport Power propose the following procedural schedule which amends the deadline for filing the Consumer Advocate’s testimony by one (1) week and extends the deadline for Kingsport Power to determine if it wants to pursue any discovery. The proposed schedule postpones the pre-hearing telephone conference by one (1) week, but maintains the Authority’s target hearing date.¹

July 14, 2015:	CA pre-filed testimony
July 17, 2015:	Kingsport Power to determine whether they want discovery and if any other issues have arisen
July 30, 2015:	Pre-Hearing Telephone Conference, 2:00pm Central Time
August 17, 2015:	Target Hearing Date

The parties are flexible regarding the proposed date and time for the pre-hearing telephone conference, recognizing that this event is dependent upon the Hearing Officer’s schedule.
