# Tennessee Wastewater Systems, Inc. Docket 15-00025 September 2019 Report Overview

Systems subject to Notice of Violations and other Corrective Orders:

Summit View – Docket 14-00136 – TDEC has reinstated the construction plans for the site. A NOV was issued for the site on August 20<sup>th</sup>. TWSI investigated the claims in the NOV and did not find evidence of the violations as alleged in the NOV.

River Road\* (NOV) - TWSI is awaiting a signed easement for the land occupied by the sewer system. This is the final requirement TDEC had for resolution of the NOV.

Hidden Springs Resort (Commissioner's Order) – Awaiting plans approval from TDEC. An Agreed Order is being negotiated with TDEC that will put a timeframe on the competition of the expansion project. A petition will be filed with the Commission seeking approval to spend funds from TWSI's escrow and reserve accounts for this project. A NOV was issued for this site related to the ongoing issues addressed in the Commissioner's Order. TWSI addressed the concerns raised in the NOV and reasserts that the plant must be expanded to ensure proper operation.

\* River Road is not included in the KPI Report because there is no discharge from the facility and is not monitored.

On August 6, 2019, Michael Caudill, Billy Roach, and Macy Brummitt from the Tennessee Division of Water Resources conducted a complaint investigation due to the discharge of sewage from failing treatment facilities and drip fields from Hidden Springs Resort operating under State Operating Permit 00-068. Billy Roach and Macy Brummitt conducted a follow-up investigation again on August 12, 2019. Below are the findings.

#### **Investigation Findings**

During the investigation the day of August 6, 2019, Hidden Springs Resort's wastewater treatment plant was observed overflowing sewage from a pump station and running into drainage leading to Seaton Branch. During the August 12, 2019 follow-up investigation the sewage in the drainage leading to Seaton Branch was still observable, however the overflow from the pump station was no longer present. Also noted in this investigation the effluent is flowing on the surface of the ground in the drip field area and not assimilating into the soil profile. Based on these observations the following are violations of the effluent limits established in State Operating Permit 00-0068.

Part II.A.4. of the State Operating Permit states:

The permittee shall at all times properly operate and maintain all facilities and systems (and related appartenances) for collection and treatment which are installed or used by the permittee to achieve compliance with the terms and conditions of this permit.

Part II.C.2.a & 3.b Reporting of Noncompliance & Overflow

2.a. In the case of any noncompliance which could cause a threat to public drinking supplies, or any other discharge which could constitute a threat to human health or the environment, the required notice of non-compliance shall be provided to the appropriate Division environmental field office within 24 hours from the time the permittee becomes aware of the circumstances.

#### 3.b. Overflows are prohibited.

Tennessee Wastewater Systems, Inc must respond in writing to this Notice of Violation by September 6, 2019 with a plan for correcting the violations documented in this letter. At this time, a Corrective Action Plan (CAP) must be developed and implemented to ensure compliance with current State Operating Permit 00068. The CAP should include, but not be limited to, modifications to operation and maintenance necessary to eliminate violations and a timeline in which the modifications will be put into operation.

This letter is in response to the Notice of Violation (NOV) issued to Tennessee Wastewater Systems, Inc. (TWSI) on August 20, 2019 arising from an inspection by TDEC personnel at Summit View Resort in Sevierville, TN on August 6, 2019. TWSI was not notified of the inspection as required under the terms of the SOP, nor was TWSI aware of any complaint about the operation of the system. The NOV alleges certain violations of the SOP and requests that a Correction Action Plan be submitted to address the concerns raised in the NOV.

TWSI requested documentation, including photos, videos, and field notes from the inspection so that it may better respond to the allegations in the NOV. However, at the time of filing this response, no information has been provided, so this response is based upon TWSI's own investigation of the concerns raised in the NOV.

Upon investigation, TWSI observed no sewage overflowing from the facility. The pipe identified in the NOV as the source of the overflow is the drain tile for the control building. One of the inline pumps had a loose fitting that resulted in water trickling out of the exterior drain. The pump was sealed and there is no more trickling water.

There was no effluent visibly flowing on the ground in drip zones 1 and 2. The zones were in fact relatively dry, even considering TWSI was at the site on the day of a rain event. The drip fields were inspected, and no evidence found that effluent washed out any pathways or that there had been any recent soil saturation. TWSI will continue to monitor the drip fields.

On August 6, 2019, Michael Caudiil, Billy Roach, and Macy Brummitt from the Tennessee Division of Water Resources conducted a complaint investigation due to the discharge of sewage from failing treatment facilities and drip fields from Summit View Resort operating under State Operating Permit 06-035. Below are the findings.

#### Investigation Findings

During the investigation the day of August 6, 2019, Summit View Resort's wastewater treatment plant was observed overflowing sewage from a pipe near the sand filter and control building. Also noted in this investigation the effluent is flowing on the surface in several locations on the ground where the new drip lines had been installed and the treated effluent was not assimilating into the soil profile. Based on these observations the following are violations of the effluent limits established in State Operating Permit 06-035.

#### Part II.A.4. of the State Operating Permit states:

The permittee shall at all times properly operate and maintain all facilities and systems (and related appartenances) for collection and treatment which are installed or used by the permittee to achieve compliance with the terms and conditions of this permit.

This letter is in response to the Notice of Violation (NOV) issued to Tennessee Wastewater Systems, Inc. (TWSI) on August 13, 2019 arising from an inspection by TDEC personnel at Hidden Springs Resort in Sevierville, TN on August 6, 2019 and a follow up visit on August 12, 2019. TWSI was not notified of either inspection as required under the terms of the SOP, nor was TWSI aware of any complaint about the operation of the system. The NOV alleges certain violations of the SOP and requests that a Correction Action Plan be submitted to address the concerns raised in the NOV.

Upon learning about the inspection and findings, TWSI personnel conducted their own investigation and found some solenoid valve wiring was damaged. The wiring was repaired and dosing to the drip fields has returned to normal function. TWSI also removed and cleaned several pumps from the discharge and recirculation tanks which has returned the system to a normal level of operation.

To correct the issues at Hidden Springs, the plant must be expanded. TWSI is presently awaiting approval of its plans to expand the Hidden Springs plant. Work will begin once TDEC approves the plans and the Tennessee Public Utility Commission approves funding.
