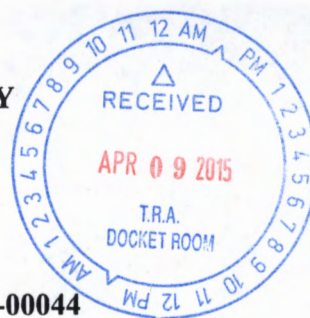

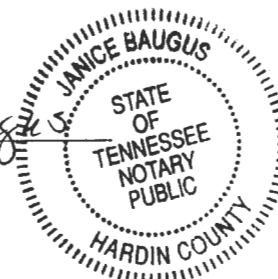

Dear valued customer:

On April 9, 2015, Aqua Utilities Company filed a Joint Petition with the Tennessee Regulatory Authority to increase rates for water and wastewater services. Aqua's service rates were last increased on February 5, 2007. The Company has made efforts to control the costs of providing utilities services, but the current increases are necessary to cover revenue shortfalls due to increased expenses of operating these systems over the last eight years. In sum, Aqua Utilities Company is requesting the following rate changes:
