I am sorry I am just now responding, I am traveling for work all of this week.

Respondent apologizes for not submitting a response, respondent believed that after the August 17, 2015 TRA hearing, that the current suit against Laurel Hills would be moot due to the ruling that Laurel Hills must remove itself from the operations and management of the Renegade Mountain Water System. Per the settlement agreement, Laurel Hills agreed to place the Renegade Water system into a voluntary receivership chosen by the TRA. As such, Laurel Hills has no power to grant access to the Renegade Water system because they no longer have any power to operate or manage the water system. The decision of who can and cannot hook up to the Renegade Water system is now in the hands of the voluntary receivership chosen by the TRA.

Further, even if Laurel Hills wanted to grant water access to the Renegade Water System in the interim before a voluntary receivership was chosen by the TRA, there remains the open question of whether they are precluded from such actions because the TRA denied them the certificate of public convenience and necessity to operate the Renegade Mountain Water System. Unfortunately, Respondent certainty cannot get an answer to this issue before the system is turned over to the receiver.

To the extent that a response is still required, Respondent would respectfully request an extension <u>until Monday</u> .
