## NOTICE TO THE HEARING OFFICER

Comes now the Tennessee Regulatory Authority ("TRA" or "Authority") Staff
Appointed as a Party ("TRA Party Staff" or "Party Staff") and provides this *Notice to the*Hearing Officer:

Pursuant to a previous filing by TRA Party Staff styled *Notice to the Hearing Officer Concerning Discovery* filed on September 19, 2016, TRA Party Staff indicated that it intended to respond to *Moy Toy, LLC's First Request for Discovery and Request for Admissions* ("Discovery Request") by November 16, 2016. However, on November 14, 2016, the Cumberland County Chancery Court ordered that the parties, including Moy Toy, LLC ("Moy Toy") and the TRA submit to global mediation within forty-five (45) days. Accordingly, TRA Party staff does not believe it appropriate to respond to Moy Toy's *Discovery Request* at this time. If this mediation does not resolve the issues pending in this present proceeding, TRA Party Staff will respond to Moy Toy's *Discovery Request* following the conclusion of the Court-ordered mediation.

TRA Party staff would like to reiterate that it believes that a formal deadline does not currently exist for it to respond to Moy Toy's *Discovery Request* as a discovery schedule has not

been issued in this case. If the hearing officer believes it prudent to enter a discovery schedule or otherwise require a response from Party Staff sooner, Party Staff will reasonably comply with that order or deadline.
