Dear Chairman Hilliard:

Please find enclosed for filing in the above-captioned matter *Tennessee-American Water Company's Final Revised Exhibits, Schedules and Workpapers in support of the Petition.* The previously submitted exhibits, schedules and workpapers were revised during the cooperative discovery process. All of the changes and modifications reflected in the attachments have already been submitted as part of the official record by TAWC. This filing is being made at the request of the Authority merely to compile all of the revisions in a single filing, with a single filing date for ease of reference.

For ease of reference, the following is a summary outline of the filing. Attached is the final version of excel files for the Exhibit TAW_EXH_LCB_1, Exhibit TAW_EXH_LCB_2 and supporting workpapers for Chemical Expense, Revenues, Fuel and Power Expense, Purchased Water Expense, TRA Inspection Fee and Waste Disposal Expense. Many of these documents were revised during the course of the proceeding, up through and including April 29, 2016.

The Exhibit TAW_EXH_LCB_1 that was originally attached to Linda Bridwell's pre-filed testimony is the calculation of the Production Costs and Other Pass-throughs percentage. The last version of the file was attached in a supplemental response to the TRA's first request for information, Item 6, filed on April 29, 2016. This supports the revised calculation of the PCOP at -0.36%. The excel version of the file is included as TAW EXH LCB 1 Revised 043016.

The Revenue Workpapers file was revised and the final version attached in response to the TRA's first request for information, Item 8, filed on April 27, 2016. The excel version of the file is included as TAW_R_TRADR_008_Attach_Revenue Workpaper_Revised 042616.

The Chemicals Workpapers file was revised and the final version attached in a supplemental response to the TRA's first request for information, Item 6, filed on April 29, 2016. The excel version of the file is included as TAW_R_TRADR_006_Attach_Workpaper_ Chemicals_Revised 042616_supp 043016.

The Fuel & Power Workpapers file was revised and the final version attached in response to the TRA's first request for information, Item 5, filed on April 27, 2016. The excel version of the file is included as TAW R TRADR 005 Attach Fuel & Power Revised 042616.

The Purchased Water Workpapers file was revised and the final version attached in response to the TRA's first request for information, Item 4, filed on April 27, 2016. The excel version of the file is included as TAW R TRADR 004 Attach Purchased Water Revised 042616.

The Waste Disposal File was revised and the final version attached in response to the CPAD's second request for information, Item 3, filed on April 12, 2016. The excel version of the file is included as Workpaper_Waste Disposal_Revised.

The TRA Inspection Fee workpapers, which were originally filed with the Petition, were not revised during the course of the proceeding. The excel version of the file is included as TRA Inspection Fee Workpaper.

Finally, the Exhibit TAW_EXH_LCB_2 was also originally attached to Linda Bridwell's prefiled testimony and reflects the impact to the average bill. This exhibit was not revised during the course of the proceeding. But, with the revised PCOP percentage, the impact to the average bill does change slightly. Therefore, a revised version is submitted here. The excel version of the file is included as TAW_EXH_LCB_2 Revised 050416.

Please note that other than the Exhibit 2, none of these files have been changed since their final version was filed. However, we are attempting to assure that the record in the case has a compilation of the final version of any revised files.

At the hearing, the parties will request that all discovery be made a part of the evidentiary record in this matter.
