Pursuant to the Company's revised Performance Based Ratemaking Tariff approved in this docket, Atmos Energy is required to file calculations of shared savings and shared costs not later than 60 days after the end of the quarter. Tariff Page 45.7. Atmos Energy has been working diligently to complete and the first such report applying the tariff changes adopted in this docket, incorporating the changes to the PBR mechanism and applying those changes to the period starting April 2016. Atmos Energy respectfully requests an extension of 45 days to the deadline to submit this first report, thus moving the deadline to April 16, 2017.
