Mr. Lambert,

We have some concerns that The Nexus Group, Inc. has previously operated under the name Loadpoint Telecommunications, LLC. We have a company (Loadpoint Telecommunications, LLC) as becoming certified in Docket No. 98-00869 and doing business at 1661 Murfreesboro Pike, #A Nashville, TN 37217.

Loadpoint's authority was cancelled at the December 19, 2000 Conference for non-payment of fees and non-payment of the contribution to the Small and Minority-Owned Business Assistance Program. The company's authority was reinstated on March 26, 2002.

In December 2009, we have noted that a Susan Osburn phoned to inquire about the need to keep the First TN Bank Letter of Credit. She was told the LOC must be maintained as long as the company is a certified telecommunications provider. On September 1, 2010, we received a Cancellation Notice from First TN Bank on the Letter of Credit for Loadpoint Telecommunications, LLC, to be effective February 28, 2011. I made multiple attempts to contact the company, by phone and in writing at the 1661 Murfressboro Rd address and also at an address on West End Avenue in Nashville, TN, with no success.

Also, their annual Statement of Gross Earnings and Computation of Inspection Fee form and payment was due April 1, 2011. They did not pay. Our Fiscal Officer attempted on several occasions to contact the company in writing via certified letter, but no response or payment was received, so the company was cancelled for non-payment of fees at the February 27, 2012 conference.

During this time, Loadpoint apparently negotiated an interconnection agreement with BellSouth Telecommunications, Inc. d/b/a AT&T Tennessee in Docket No. 10-00186. That ICA was signed by Robert England, CFO for Nexus/Loadpoint, 1661 Murfreesboro Rd. #A Nashville, TN 37217. This ICA was approved prior to the cancellation in 2012.

We have concerns as to: 1) If this is the same company, previously doing business as Loadpoint, are they going to comply with our rules, pay their fees, and maintain a bond or LOC as required by all telecommunications companies operating in Tennessee, and 2) If this is the same company, they will need to take care of outstanding fees and late penalties before we can proceed with this application.

Can you pass our concerns on to your client and please advise?
