Please accept the original and four (4) copies of this filing are submitted on behalf of Zayo Enterprise Networks, LLC to notify the Tennessee Regulatory Authority that the Company has changed its name to Voyant Communications, LLC. The Company respectfully requests that the Tennessee Regulatory Authority issue an updated certificate, if applicable, to reflect the Company's name as "Voyant Communications, LLC."

The Company is authorized to provide facilities-based and resold competing local telecommunications services and facilities-based and resold interexchange telecommunications services in Tennessee pursuant to authority granted in Docket No.11-00116. The Company has opted for operating pursuant to Market Regulation - consequently it has no tariff to be updated.

Zayo Networks Enterprise is currently in the process of obtaining a Rider amending the Company's Tennessee bond to reflect the change in Company name which will be submitted under separate cover. Also enclosed is a check for \$25.00 to cover the filing fee.

A copy of the Company's name change filing with the Tennessee Secretary of State is attached hereto as Exhibit A.

The Company has changed its name as part of a recent rebranding and marketing campaign to avoid confusion between Zayo Enterprise Networks, LLC and Zayo Group, LLC. The Company's name change does not entail any restructuring, merger or other transaction impacting the corporate existence or management of the Company, and it will not affect the services or rates provided to customers of the Company.

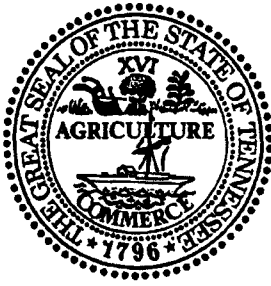
