Can you tell me to docket number you to which you are referring on the request to relinquish ETC designation? I see docket 22-00034 which was a petition for **wireless** ETC designation.

For wireline services, I see the following:

Global Connections was granted a CCN to provide resold telecommunication services in docket 99-00624. That CCN was canceled by an order dated 10/21/2020.

Global Connections was granted a CCN to provide competing local exchange telecommunication services in docket 02-00567. This CCN was also canceled by an order dated 10/21/2020.

Global Connections was granted a wireline ETC in docket no. 16-00080. There is a request for cancellation in the docket file – the same request letter filed in the two previously referenced CCN dockets – but I do not see an order that addresses the ETC relinquishment directly.
