LEGAL NOTICE

Notice is hereby given that, pursuant to its existing Annual Review Mechanism tariff, Atmos Energy Corporation (the Company) filed a Petition with the Tennessee Regulatory Authority (TRA) on September 1, 2016 in Docket 16-00105. The petition requests approval of the Company's Annual Reconciliation Revenue Requirement which is to be added to its subsequent ARM filing to be made no later than February 1, 2017. The additional revenue proposed by the Company is subject to approval by the TRA. A complete copy of the proposed revenue change and the reasons for it are on file with the TRA and are available for public inspection. A complete copy is also available in the Company's local offices. The Company has requested this change in revenue in accordance with the procedures approved in its Annual Review Mechanism tariff. The predicted impact of the proposed change on the average residential customer is an increase of approximately \$18.99 per year. The predicted impact of the proposed change on the average small commercial class customer is an increase of approximately \$83.53 per year. The impact will be in addition to any change in rates proposed in its February 1, 2017 ARM filing. Now rates, representing the combined impact of Docket 16-00105 and the subsequent February 1, 2017 ARM filing will be proposed to be billed beginning June 1, 2017. The matter is set for hearing January 17th, 2017, beginning at 1:00 p.m. or as soon thereafter as it may be heard, in the TRAs Hearing Room on the ground floor of the Andrew Jackson State Office Building, 500 Dandridge Street, Nashville, Tennessee.
