

If an objection is filed within the ten-day period, the agreement or amendment will not be deemed approved and will be scheduled for consideration before the assigned panel of directors at a subsequent Authority Conference. If no objection to the agreement or amendment is filed within the ten-day period, the Authority will issue a notice memorializing approval of the interconnection agreement or amendment.
