ORDER GRANTING SECOND MOTION FOR EXTENSION OF TIME AND AMENDING
PROCEDURAL SCHEDULE


This matter is before the Hearing Officer of the Tennessee Public Utility Commission ("Commission" or "TPUC") upon the *Motion for Extension of Time to File Consumer Advocate's Pre-filed Direct Testimony and Request for Expedited Consideration of this Motion* ("Second Motion for Extension") filed by the Consumer Protection and Advocate Division of the Office of the Attorney General ("Consumer Advocate" or "CPAD") and the *Joint Filing of Revised Proposed Procedural Schedule* filed by CPAD and Tennessee Wastewater Systems, Inc. ("TWSI") on May 17, 2017.

On April 7, 2017, the Consumer Advocate filed an *Expedited Motion for Extension of Time to File Consumer Advocate's Pre-filed Testimony* requesting an extension of time until May 19, 2017 to file its Pre-filed Testimony. On April 18, 2017, the parties filed a *Joint Filing of Revised Proposed Procedural Schedule* reflecting agreements between the parties regarding the Procedural Schedule. Subsequently, the Consumer Advocate filed its *Second Motion for Extension* on May 12, 2017, requesting an additional extension of time until May 31, 2017, to file its Pre-filed Direct Testimony. The Consumer Advocate states it needs additional information from TWSI and additional time to complete its analysis before filing its Pre-filed Testimony. TWSI filed a *Response*

to Motion of Consumer Advocate for Another Extension of Time to File Testimony opposing the Consumer Advocate's *Second Motion for Extension*.

The Hearing Officer conducted a telephone status conference with the parties on May 6, 2017. During the Status Conference, the parties indicated they had reached an agreement on the Procedural Schedule and filed the *Joint Filing of Revised Proposed Procedural Schedule* on May 17, 2017. Based on the *Joint Filing of Revised Proposed Procedural Schedule* filed by the parties, the Hearing Officer hereby establishes the Procedural Schedule set forth in **Exhibit A** attached to this Order.
