Pursuant to Section 4.5.2 of AT&T Tennessee's Self-Effectuating Enforcement Mechanisms Administration Plan ("SEEM Plan"), AT&T Tennessee declared a force majeure event that began September 26, 2024, in connection with Hurricane Helene.

As of the end of business on October 29, 2024, AT&T Tennessee hereby lifts the force majeure declaration for this event in certain wire centers for all Service Quality Measures ("SQMs") associated with Provisioning, Trunk Group Performance, and Maintenance & Repair measures. The attached spreadsheet identifies the wire centers impacted by this partial lift. The force majeure event remains in effect in wire centers identified as having no end date in the attached spreadsheet.
