
**ORDER ESTABLISHING PROCEDURAL SCHEDULE**

This matter came before the Hearing Officer of the Tennessee Public Utility Commission (“Commission” or “TPUC”) at a Status Conference held on April 11, 2017 to discuss the issues in the docket and to establish a procedural schedule for the orderly administration of these proceedings. Integra Water Tennessee, LLC (“Integra”) and the Consumer Protection and Advocate Division of the Office of the Attorney General (“Consumer Advocate”), the parties in this matter, were represented by counsel at the Status Conference. During the Status Conference, the parties discussed potential issues in the docket and developed a procedural schedule.

The goal and design of any procedural schedule is to efficiently move the proceedings forward to a hearing and final conclusion on the merits. Nevertheless, a procedural schedule’s effectiveness directly depends on cooperation by the parties in meeting the individual benchmark dates. Based on the agreements made by the parties regarding the procedural schedule, the Hearing Officer hereby establishes the Procedural Schedule set forth in **Exhibit A** attached to this Order.
