This First Discovery Request is hereby served upon Integra Water Tennessee, LLC. (Company), pursuant to Rules 26, 33, 34 and 36 of the Tennessee Rules of Civil Procedure and Tenn. Comp. R. & Reg. 1220-1-2-.11. The Consumer Protection and Advocate Division of the Attorney General's Office (Consumer Advocate) requests that full and complete responses be provided pursuant to the Tennessee Rules of Civil Procedure. The responses are to be produced at the Office of the Tennessee Attorney General and Reporter, Consumer Protection and Advocate Division, 315 Deaderick Street, 20th Floor, Nashville, Tennessee 37243, c/o Karen H. Stachowski, on or before 4:00 p.m. (CDT) May 23, 2017, or at such other time as may be ordered by the Hearing Officer in the adoption or approval of a procedural schedule in this TPUC Docket.

PRELIMINARY MATTERS AND DEFINITIONS

- (1) **Continuing Request.** These discovery requests are to be considered continuing in nature, and are to be supplemented from time to time as information is received by the Company and any of its affiliates which would make a prior response inaccurate, incomplete, or incorrect.
- (2) To the extent that the data or information requested is incorporated or contained in a document, identify the document including page/line number if applicable.
- (3) Format of Responses. Provide all responses in the format in which they are created or maintained, for example, Microsoft Word or Microsoft Excel format with all cells and formulas intact and in working order. If a document (including without limitation a financial or other spreadsheet or work paper) is not created or maintained in Microsoft Excel format, convert the document to Microsoft Excel format or provide the document in a format that enables or permits functionality like or similar to Microsoft Excel (including without limitation the functionality of working cells and formulas), or provide the software program(s) that will enable the Consumer Advocate to audit and analyze the data and information in the same manner as would be enabled or permitted if the document were provided in Microsoft Excel format.

- (a) "You" or "your" or "Company" or "Integra Water" as used herein mean Integra Water Tennessee, LLC and all employees, agents, attorneys, representatives or any other person acting or purporting to act on its behalf.
- (b) "Affiliate" shall mean any entity who, directly or indirectly, is in control of, is controlled by, or is under common control with the Company. For greater clarification, "control" is the ownership of twenty percent (20%) or more of the shares of stock entitled to vote for the election of directors in the case of a corporation, or twenty percent (20%) or mere of the equity interest in the case of any other type of entity, or status as a director or officer of acorporation or limited liability company, or status as a partner of a partnership, or status as an owner of a sole proprietorship, or any other arrangement whereby a person has the power to choose, direct, or manage the board of directors or equivalent governing body, officers, managers, employees, proxies, or agents of another person. In addition, the term "affiliate" shall mean any entity that directly or indirectly provides management or operational services to the Company or any affiliate (as defined in the preceding sentence) of the Company, or to which the Company provides management or operational services. Further, the payment of money to the Company or receipt by the Company of money from an entity with which the Company has any relationship, other than such payment or receipt, shall include the payor or recipient of such money as an "affiliate" for purposes of this Discovery Request.

- (c) "Person" as used herein refers to any natural person, corporation, firm, company, proprietorship, partnership, business, unincorporated association, or other business or legal entity of any sortwhatsoever.
- (d) "Communication" means any transmission of information by oral, graphic, written, pictorial or otherwise perceptible means, including but not limited to personal conversations, telephone conversations, letters, memoranda, telegrams, electronic mail, newsletters, recorded or handwritten messages, meetings and personal conversations, or otherwise.
- (e) "Document" as used herein shall have the broadest possible meaning under applicable law. "Document" as used herein means any medium upon which intelligence or information can be recorded or retrieved, such as any written, printed, typed, drawn, filmed, taped, or recorded medium in any manner, however produced or reproduced, including but not limited to any writing, drawing, graph, chart, form, letter, note, report, electronic mail, memorandum (including memoranda, electronic mail, report, or note of a meeting or communication), work paper, spreadsheet, photograph, videotape, audio tape, computer disk or record, or any other data compilation in any form without limitation, which is in your possession, custody or control. If any such document was, but no longer is, in your possession, custody or control, state what disposition was made of the document and when it was made.

(f) "Identify" with respect to:

1. any natural person, means to state the full name, telephone number, and the last known address of business address of the person and that person's

Regardless, given the anticipated operating expenses of the Casey Cove system, as more fully outlined in Integra's petition and supporting documentation, Integra reasonably believes that the system can be built and maintained with the current projected customer base and remains committed to ensuring the project's financial stability.

RESPONSE: In TPUC Data Request 26, Company provided the following response:

"In the event an account becomes diligent to the point that collection proceedings require a discontinuation of service, Integra Water will mobilize a technician to lockout the service. Integra Water defines actual cost as the cost of labor, parts & equipment necessary to disconnect the service. In the case of Casey Cove, this will be subcontracted, so Integra will pass along the cost of the disconnect directly to the customer without a G&A or profit markup. Integra only charges the customer the cost borne by Integra to disconnect service."

It was not the company's intent to be non-responsive. Rather, these cost may vary depending on site specific conditions and whether work is subcontracted. Our philosophy is that customers that pay in a timely fashion should not have to subsidize the cost of collections for those customers that are delinquent. As such, there is a range of disconnection cost from \$50 - \$150 in North Carolina and Alabama. We expect that the cost of disconnection for Casey Cove to be similar to North Carolina and Alabama.

RESPONSE: Customers can pay by check, Auto draft, over the phone, or online.

SUPPORT SERVICES AGREEMENT BETWEEN INTEGRA WATER, LLC AND INTERGRA WATER TENNESSEE, LLC

This Support Services Agreement ("Agreement") is made as of the _____ day of _____, 2016, by and between Integra Water, LLC, a Georgia limited liability company with a principal place of business in Birmingham, Alabama ("Integra"), and Integra Water Tennessee, LLC, an Alabama limited liability company with a principal place of business in Birmingham, Alabama ("IWTN") (collectively referred to as the "Parties").

RECITALS

WHEREAS, Integra has experience and expertise in matters involving management, financing, accounting, customer service, rate-making and regulatory compliance, and the operation of water and wastewater utilities; and

WHEREAS, IWTN is in the business of owning and operating water and wastewater utilities in the State of North Carolina; and

WHEREAS, IWTN is a subsidiary of Integra; and

WHEREAS, Integra is knowledgeable of the business and operations of IWTN, and is qualified to aid, assist, and advise IWTN in IWTN's business operations through the services to be performed under this Agreement; and

WHEREAS, the Parties are entering into this Agreement to specifically define the services that Integra may provide to IWTN, as set forth in Exhibit A attached hereto and made a part hereof; and

WHEREAS, Integra has entered into or proposes to enter into agreements similar to this Agreement with other water and wastewater companies that are subsidiaries of Integra (collectively referred to as the "Water Companies") so that Integra may provide the same or similar services to IWTN along with other Water Companies; and

WHEREAS, Integra and IWTN desire to enter into this Agreement, upon the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the agreements contained herein, the Parties agree as follows:

ARTICLE I SCOPE OF PROVIDER SERVICES

1.1. <u>Support Services</u>. During the term of this Agreement and pursuant to the

terms and conditions set forth herein, Integra may provide to IWTN corporate management services, including accounting and financial services, administrative services, communications services, corporate secretarial services, customer service and billing services, financial services, human resource services, information system services, operation services, support services for rates and regulatory compliance, risk management services, assistance in legal matters, and purchasing services, as set forth in Exhibit A, together with such other services to which IWTN and Integra may agree. Integra may provide such services to IWTN as IWTN shall reasonably require from time to time.

The Parties acknowledge that IWTN's election to use services offered by Integra must be consistent with IWTN's obligation to provide safe, reasonable, and adequate service at rates which are just and reasonable to customers. IWTN's election to use services offered by Integra must be based on the value of the services, including, but not limited to, the price of the services, the experience of the personnel providing the services, and the quality of the services to be provided. Services provided by Integra shall be performed with due care and in a prudent, professional and workmanlike manner.

- 1.2. <u>Services Provided in a Reasonable and Efficient Manner</u>. Integra shall provide support services to IWTN in a reasonable, timely, and efficient manner.
- 1.3. <u>No Obligation of Integra to Provide Services</u>. Integra shall have no obligation to provide any services requested by IWTN. If IWTN requests services from Integra, Integra may choose not to provide the services for any reason, including that it is not reasonably able to provide such services or that it is unable to do so in a manner consistent with applicable law.
- 1.4. <u>No obligation of IWTN to Purchase Services</u>. IWTN shall have no obligation to request or purchase services from Integra. IWTN may elect to perform any services with its own personnel, and it may engage a company other than Integra or person to provide such services.
- 1.5. <u>Integra Personnel</u>. Integra shall employ qualified officer(s) and employees to provide services to IWTN. Those persons shall be available to serve as officers of IWTN, if agreed to by the Parties. Personnel provided by Integra to perform services for IWTN shall remain employees of Integra and shall not be deemed to be employees of IWTN. Integra shall be responsible for the payment of and reporting of all taxes for such personnel including, without limitation, employment, unemployment, social security tax, federal and state withholding tax, local tax and any other tax required by law.

Integra shall provide well-qualified and experienced staff to perform services covered under this Agreement. Names and backgrounds of said personnel shall be provided to IWTN upon request.

In addition to using Integra personnel to provide services to IWTN, Integra may engage or contract with other companies or persons, including affiliated companies, to provide such services on its behalf.

ARTICLE II BILLING AND PAYMENT FOR SERVICES

- 2.1. <u>Cost of Services</u>. All services rendered by Integra to IWTN shall be charged to IWTN at the lesser of Integra's actual cost or market rate.
- 2.2. Services Provided to IWTN System or to Individual System. Integra may provide services to the entire IWTN system or to an individual IWTN water or wastewater system. When Integra provides services to the entire IWTN system and does not provide the same services to the other Water Companies, Integra shall charge IWTN for the amount of time Integra employees billed to the system. For services that Integra provides only to an individual IWTN system, Integra shall charge the individual system for the amount of time Integra employees billed to that system.
- 2.3. Allocation of Cost for Same or Similar Services. When Integra provides the same or similar services to IWTN and the other Water Companies, the cost for such services shall be allocated to IWTN and other Water Companies in a fair and equitable manner. For example, when services are provided to the entire IWTN system and the other Water Companies, the cost to IWTN shall be based upon the ratio of the number of active residential equivalent IWTN customers in the immediately preceding calendar year-end to the total number of active residential equivalent customers of the other Water Companies in the immediately preceding calendar year-end. When services are provided to an individual IWTN system and other Water Companies, the cost to the individual IWTN system shall be based upon the ratio of the number of active residential equivalent customers of the individual IWTN system in the immediately preceding calendar year-end to the total number of active residential equivalent customers of the other Water Companies in the immediately preceding calendar year-end.

Customer counts for IWTN and the other Water Companies will not be adjusted until the calendar year-end unless there is a substantial acquisition by Integra or IWTN. In that event, the customer count will be updated, and allocations will be based upon the updated customer count.

- 2.4. <u>Integra Employee Costs</u>. The cost of Integra personnel to be charged to IWTN shall be calculated on a per hour basis, and shall be based on the personnel's total labor rate that includes base pay and other compensation, payroll taxes, fringe benefits, and share of overhead, as defined in Section 2.6. Integra personnel shall keep timesheets documenting work performed for IWTN.
- 2.5. Overhead. Integra overhead shall include, but not be limited to, building costs, lease costs, depreciation, utilities, other costs associated with office space

and equipment, and taxes other than payroll taxes. Integra shall calculate overhead on an annual basis. The allocation of overhead to each Integra officer and employee shall be based on the ratio of total overhead for the year to the total salaries of the employees for whose service charges are to be made to IWTN and the other Water Companies. Overhead shall not be added to costs incurred for services of consultants or other third parties employed by Integra.

- 2.6. <u>Invoices</u>. Integra shall submit itemized invoices for services rendered to IWTN, as soon as practicable after the close of each month. All invoices submitted by Integra shall have adequate documentation to identify the specific services, the cost of direct billed and allocated services, and the person providing the service, and to justify all labor and materials costs. In addition, Integra shall provide adequate documentation showing how it calculates its direct and allocated costs each time it submits an invoice reflecting a type of service for which it has not previously documented its methodology, and each time it changes any material element of the calculation.
- 2.7. <u>Records</u>. Integra shall maintain all time records and bills of service (including requests) in a manner that facilitates accurate and complete monitoring of specific charges and services under this agreement.
- 2.8. Payment of Invoices. IWTN shall pay each invoice within thirty (30) days after receipt to the extent the charges are not disputed. IWTN must raise any such disputes by written notice to Integra within six (6) months after receipt of the invoice with the disputed cost. IWTN shall pay Integra interest at an annual rate equal to one and one-half percent (1.5%) per month that shall accrue on any undisputed invoice not paid within thirty (30) days after receipt by IWTN, with such interest being computed from the thirtieth (30th) day following the date of receipt.
- 2.9. <u>Inspection of Books and Records</u>. Upon the written request of IWTN, Integra shall permit IWTN or its authorized agent reasonable access to its books and records for the purpose of auditing charges billed by Integra to IWTN.

ARTICLE III TERM OF CONTRACT

This Agreement shall commence on the date first written above and continue until terminated by either Party by at least sixty (60) days prior written notice to the other.

ARTICLE IV CHANGES

No waiver, alteration, amendment, consent or modification of any of the provisions of this Agreement shall be binding unless in writing and signed by a duly authorized representative of all parties.

ARTICLE V ASSIGNMENT

Integra and IWTN may not assign any of their rights or obligations hereunder except with the prior written consent of the other Party hereto.

ARTICLE VI FORCE MAJEURE

Force Majeure means an event which is beyond the reasonable control of and without the fault or negligence of the Party claiming Force Majeure, which delays, hinders or prevents performance of that Party's obligations under this Agreement other than IWTN's obligation to pay Integra for services provided. Neither Party shall be liable to the other Party for loss or damage resulting from any delay in performance in whole or in part or nonperformance of contractual obligations in whole or in part insofar as such delay or nonperformance is caused by Force Majeure, provided that the Party invoking Force Majeure provides written notice to the other Party of the circumstances giving rise to such delay or nonperformance within a reasonable time after learning of such circumstances.

ARTICLE VII INSURANCE

- 7.1. Obligation to Provide Insurance. With respect to the services performed under this Agreement, Integra shall purchase and maintain insurance coverage in at least the following amounts:
- a. Workers' compensation i nsurance or self-insurance, naming IWTN as an alternate employer, including the following extensions if necessary, Federal Longshoremen's and Harbor Worker Act, Jones Act or any similar employee benefit act that complies with the provisions of applicable federal and state law.
 - b. Liability insurance with limits not less than \$100,000 for each occurrence.
- c. Comprehensive general liability insurance that insures IWTN as an additional insured, with limits not less than \$1,000,000 combined bodily injury and property damage liability.
- d. Automobile liability insurance with limits not less than \$1,000,000 for combined bodily injury and property damage liability. Integra shall provide IWTN with certificates of insurance prior to the execution of this Agreement. The certificates of insurance shall state that the carrier will endeavor to provide a thirty (30) day written

notice of cancellation to IWTN resulting from all causes other than failure to pay premiums, in which case the carrier will endeavor to provide ten (10) days written notice of cancellation to IWTN.

ARTICLE VIII INDEMNIFICATION

Each Party shall indemnify and hold the other Party harmless from all damages, injuries, claims, demands, judgments, penalties, fines, liens, costs, and expenses, including reasonable attorneys' fees, of whatsoever kind or nature arising out of this Agreement, in any way contributed to by the negligence, act, omission, or fault of that Party. To the extent that an employee of Integra or a subcontractor or employee of an affiliate of Integra brings an action against IWTN, Integra agrees to waive its workers compensation immunity with respect to any claim of contribution or indemnification that IWTN may have against Integra.

ARTICLE IX NOTICE

All communications and notices by IWTN to Integra under this Agreement shall be sent to and addressed as follows:

Either party may change the address set forth by written notice to the other.

ARTICLE X APPLICABLE LAW

This Agreement shall be governed by and construed in accordance with the laws of the State of Tennessee without regard to its choice of law rules, and it shall be

subject to approval by the TRA, if required.

ARTICLE XI ENTIRE AGREEMENT

This Agreement constitutes the entire Agreement between the Parties for the services to be provided hereunder, and supersedes all prior representations and agreements, whether written or oral, between the parties as to such services.

IN WITNESS WHEREOF the Parties hereto have caused this Agreement to be executed in duplicate by their duly authorized representatives to become effective as of the data first written above.

DESCRIPTION OF SUPPORT SERVICES

Services that may be provided by Integra to IWTN shall include, but not be limited to, the following services:

A. Accounting and Financial Services. Integra will assist in the preparation and implementation of accounting methods and procedures to ensure that they conform fully to the requirements, rules and regulations of governmental authorities having jurisdiction over IWTN. Integra will review IWTN's monthly financial reports, annual reports, and other reports, including those to governmental authorities. Integra will advise and assist in the establishment and maintenance of current record keeping techniques; review accounting procedures, methods and forms; and evaluate systems of internal control for receipt and disbursement of funds, materials, supplies, and other assets. Integra will assist in the maintenance of accounting records. When appropriate, Integra will cooperate and consult with IWTN's certified public accountants. Integra will provide assistance to IWTN in the preparation of all financial reports, and provide the financial reports to IWTN on a monthly basis no later than the tenth day of following month. Integra will provide services related to accounts payable, payroll, consolidation, budgeting and long-range planning.

Integra will assist in the preparation of operating and construction budgets and monitor the control over such budgets by comparing realized costs to the projected costs.

Integra will prepare or assist in the preparation of federal, state and local tax returns to the extent required by IWTN.

- B. <u>Administrative Services</u>. Integra will make qualified employees available to perform or assist in the performance of IWTN's corporate activities. Those employees will keep themselves informed as to IWTN's operations. They will make recommendations to IWTN for operating expenditures and for additions to and improvements of property, plant, and equipment. They will keep abreast of economic, regulatory, governmental and operational developments and conditions that may affect IWTN, and advise IWTN of such developments and conditions to the extent that they may be important to IWTN.
- C. <u>Communications Services</u>. Integra will recommend procedures to promote satisfactory relations with employees, customers, communities, and the general public, including plant tours, public exhibits and displays, and other related services.
- D. <u>Corporate Secretarial Services</u>. Integra will maintain, in such places and manner as may be required by applicable law, documents of IWTN, such as minute books, charters, by-laws, contracts, deeds and other corporate records. Integra will perform other corporate secretarial functions as required, including preparation of notices of director meetings and the minutes thereof.

Integra will review and assist in the preparation of documents and reports required by

IWTN, including deeds, easements, contracts, charters, franchises, trust indentures, and reports and filings to the Tennessee Regulatory Authority.

- E. <u>Customer Service and Billing Services</u>. Integra will provide customer service and billing services to IWTN, including live and automated telephone service to customers, the rendering of periodic bills to customers based on the required tariffs, collections, assisting customers with water service changes, resolving customer disputes, and remittance processing.
- F. <u>Financial Services</u>. Integra will assist in the development and implementation of financing programs for IWTN, including the furnishing of advice from time to time on securities market conditions and the form and timing of financing, and assistance in the preparation of necessary papers, documents, registration statements, petitions, applications and declarations. Integra will prepare reports to be filed with, and reply to inquiries made by, security holders and bond and mortgage trustees.

Integra will assist IWTN in treasury and cash management functions, including arrangements for bank credit lines, establishment of collection policies, and development of temporary investment programs.

- G. <u>Human Resource Services</u>. Integra will assist in obtaining qualified personnel for IWTN, in establishing appropriate rates of pay for those employees, and in negotiating with bargaining units, if any, representing IWTN's employees. Integra will advise or assist and/or carry out training programs for the development of personnel and advise and assist IWTN regarding personnel. Integra will also advise and assist IWTN in regard to group employee insurance, pension and benefit plans, and in the drafting or revising of those plans when required. Integra will provide advice regarding employment laws and procedures and controls for compliance with such laws.
- H. <u>Information System Services</u>. Integra will make available to IWTN electronic data processing systems, networks, applications, and services. Integra will maintain a computer network, data communications system, database and applications services, desktop and laptop computers, and peripheral equipment along with periodic upgrades, data backups and recovery procedures for the benefit of IWTN
- I. <u>Operation Services</u>. Upon the request of IWTN, Integra will perform periodic operational reviews and provide recommendations for improvements.
- J. <u>Support Services for Rates and Regulatory Compliance</u>. Integra will make recommendations for changes in rates, tariffs, and rules and regulations, and assist IWTN in the conduct of proceedings before the Tennessee Regulatory Authority and in compliance with the rulings of the Tennessee Regulatory Authority. Accounting personnel may assist in the preparation of rate filings or applications and the supporting documents and exhibits requested or required by IWTN, the Tennessee Regulatory Authority, and the Public Staff -- Tennessee Regulatory Authority. Integra will also provide qualified personnel to testify on behalf of IWTN as required during any regulatory proceedings

- K. <u>Risk Management Services</u>. Integra will provide a risk management program to review the exposures to accidental loss, recommend methods of protection through the purchase of insurance, self-insurance or other risk management techniques, and arrange for the purchase of insurance coverage. Integra will also supervise investigation procedures, review claims and negotiate and assist in, and evaluate proposals for, settlement at the request of IWTN. Integra will advise IWTN on specific safety and security programs required to comply with insurance coverages.
- L. <u>Legal Services</u>. Integra will assist IWTN in retaining outside counsel to represent IWTN. This may include finding qualified legal counsel for specific legal matters and assisting with negotiating fees and terms.
- M. <u>Purchasing Services</u>. Integra will (a) utilize the purchasing power of IWTN in combination with Integra, insofar as it is feasible and at the request of IWTN in the purchase of supplies, materials and equipment; (b) endeavor to secure prompt shipment and delivery thereof; (c) and give IWTN the full benefit of all cash, trade and quantity discounts obtained with respect to items ordered for IWTN; (d) keep in touch with market conditions and endeavor to recommend purchases at advantageous times; (e) negotiate purchases and sales of real estate and the terms of leases; and (f) prepare quotations or competitive bids of suppliers or contractors on a summary bid tab for analysis by IWTN management and provide input relative thereto.

Exhibit B

SUMMARY

Integra Water, LLC ("Integra") was formed on October 27, 2004. Integra consists of officers and employees who are familiar with the water and wastewater utility business, and who have experience and expertise in corporate management services, including accounting and financial services, administrative services, communications services, corporate secretarial services, customer service and billing services, financial services, human resource services, information system services, operation services, support services for rates and regulatory compliance, risk management services, assistance in legal matters, and purchasing services. Integra employees are qualified to aid, assist, and advise water and wastewater companies in their businesses. Costs related to these services are collected and allocated to the appropriate subsidiaries and affiliated companies of Integra through a fair and appropriate allocation process.

Billing Process

All Integra officers and employees record the hours worked on behalf of a subsidiary or affiliated entity on their payroll timesheets. The timesheets are processed through Integra's payroll with the appropriate hours recorded into Integra's payroll database, which contains appropriate tables to calculate and allocate service billings to the appropriate entity.

The expenses of Integra are classified into two main categories under which a bill is produced: a service expense or a sundry expense. A service expense is comprised of the labor and overhead of Integra employees, and a sundry expense is the departmental costs associated with the normal operations of Integra and can also be categorized as listed above.

An example of the calculation of service billing is as follows:

An employee's total annual hours of 2,080 is utilized, and is based on a 40-hour work week and 52 weeks of annual paid time. The employee's actual work time is the total annual hours less the number of vacation, sick and holiday used throughout the year. In calculating the employee's work hours for the year, assume that the employee has 2 weeks of vacation (10 days or 80 hours), has 5 sick days or 40 hours per year, and has 8 days of holidays (for a total of 64 hours for the holidays). Therefore, the employee's actual number of hours worked is 1,896 hours per year:

2,080 hours - 80 hours (vacation) - 40 hours (sick) - 64 hours (holiday) = 1,896 hours.

Each employee's billable hour total is estimated at the beginning of each year based upon anticipated paid time-off (vacation, holidays, sick-time and personal days). At year's end, the employee will have billed actual time worked. Adjustments will be made for paid time-off to reconcile the difference of actual paid time-off and estimated paid time-off.

Billable Costs

Labor costs and overhead expense represent billable costs. Labor cost is defined as actual base pay of employees calculated into an hourly pay rate. Overhead expenses are additional employee compensation. As part of the budget process, these costs are identified by employee. Once the budget is final, the overhead costs for each employee are calculated by type of cost and loaded into payroll as a payroll additive to the employee's hourly rate. This payroll additive is calculated into the hourly rate based on the budget or estimated levels on the basis of time actually worked. They are recorded to the general ledger through the payroll system.

The following is an example of how employee deductions and burden is calculated.

ITEM	HOURS
------	-------

ANNUAL SALARY	\$50,000.00
BASE RATE	\$24.03846
HOLIDAYS	64
SICK	40
VACATION	80
BILLABLE HOURS	1,896
BURDEN RATE	1.097046

In the above example, the employee is paid \$50,000 per year and has estimated billable hours of 1,896. In order to ensure that all overhead costs are billed out, it is necessary to calculate a burden rate to be applied to each employee's billable rate. The burden rate is calculated by dividing actual paid hours by actual hours worked. In this example 2,080/1,896 produces a burden rate of 1.097046. This rate is applied to all billable hours for this employee.

In addition to the burden rate, each billable hour is burdened with an allocation for the employees benefit package. This includes Health Care, employer contributed Simple IRA, life insurance, and long term disability expense. The budgeted annual amount is divided over 26 pays and the burden rate of 1.097046 is applied to the cost in order to compensate for paid time off. These employer paid deductions then follow the distribution of direct payroll costs, and billable hours for each employee when payroll is processed.

Allocations

After the month-end and the allocation of service costs, all such costs will be appropriately distributed to IWTN and the Water Companies. Once the payrolls are posted, allocations are processed, and costs are distributed to each subsidiary and affiliate. An allocation pass through account is credited to offset all service related expenses within Integra. This leaves costs in the proper accounts where they can be further analyzed and reviewed. Integra will prepare reports detailing the costs allocated to IWTN.

Reconciliations

In addition to the reconciliation of the charges allocated to IWTN and the Water Companies, Integra will true-up actual expenses by type. As expenses change from budget or employees use more or less paid time off than budgeted, adjustments for these costs will be performed.

Unless significant changes to expense from budget occur, adjustments to expense will be done on a yearly basis. Reconciliations to adjust customer counts will be performed on the first day of July of each year. Also, account reconciliations will be performed on a monthly basis.


This Pay N Seconds Agreement is entered into by and between the above listed Client (CLIENT) and PNS Partners, LLC (PNS), DBA Pay N Seconds with a principal place of business at 240 Glenis Drive, Murfreesboro, Tennessee, 37129 and shall run for the benefit of other parties named herein (the "Agreement"). The Effective Date is the date that PNS signs below.

SCOPE OF SERVICES: PNS will provide billing services on behalf of CLIENT for CLIENT's consumers via a web portal found at www.paynseconds.net, automated telephone service (IVR) and Mobile payment platform SMS called Pay N Seconds. The parties may expand or limit various portions of this Agreement as contained in Addendum A to this Agreement. If there is an Addendum A, the terms of the Addendum shall control if there is a conflict between this Agreement and Addendum A. PNS is a Payment Service Provider who uses its Authorized Processors (PROCESSORS) Bank (BANK) or Banks (BANKS) (the Authorized Processors and their Bank or Banks are referred to collectively herein as "Processors" or "Authorized Processors") to settle transactions to PNS CLIENT'S through the respective card associations or ACH system for eCheck transactions.

- 1. **DEFINITIONS**. For purposes of this Agreement, the following shall apply:
- a) "Agreement" means this Agreement entered by and between PNS Partners, LLC and Client.
- b) "Client" means the party identified as such in the signature block.
- c) "Customer" means a person or business that is eligible to pay, or is required to pay, amounts due to Client.
- d) "PNS" or "PNS Partners" means PNS Partners, LLC, a Tennessee Limited Liability Company.
- e) "Processor(s)" or "Authorized Processor(s)" means any company with whom PNS has contracted to settle transactions on behalf of PNS and specifically includes any Bank(s) that Processor may use to settle any such transactions.
- f) "NACHA" means The Electronic Payments Association that manages governance of the ACH network.
- g) "ACH" means a nationwide electronic funds transfer (EFT) system that provides for inter-bank clearing of credit and debit transactions
- h) "ISO" means, collectively, PNS and its Authorized Processors and Independent Sales Organizations, along with any Bank or Banks utilized by PNS, its Authorized Processors and Independent Sales Organizations.
- i) "TMF" means the Terminated CLIENT File.
- j) "Guarantor" means, collectively, the Client, any corporation on whose behalf this Agreement is executed and any party otherwise executing this Agreement, or identified as, a guarantor.
- k) "Card Association" means, a network of issuing banks and acquiring banks that process payment cards such as Visa, MasterCard, and Discover.
- "Card" means both the plastic card and other device of the account and the account number, issued to the cardholder, which you
 accept from your customer as payment for their purchases from the CLIENT, and for the transactions with respect to which PNS
 agrees to process.
- m) "Service Fee" means a fee that is charged to the Customer for the ability to make a payment through the PNS system.
- n) "Client Service Fee" means all fees due PNS by the Client.
- o) "Principal Amount" means funds due to Client less any Service Fee on all Payment Transactions made through the PNS System.
- p) "PNS System" means any payment type utilized through Pay N Seconds in order to facilitate a Customers payment transaction.
- q) "Payment Transaction" means both Principle amount and Service Fee, all regular, periodic due, fixed dues and assessment payments, and all other amounts, fixed or variable, payable by the Customer to the Client and/or PNS.
- r) "Chargeback" means a reversal of a Card or ACH sale previously settled through the PNS system.

2. PAYMENT SERVICE TYPES:

- a) Web An online payment application that gives the Customer the option to submit a payment using the internet.
- b) IVR An automated Interactive Voice Response system that gives the customer the option to submit a payment using their telephone.
- c) POS A Point of Sale terminal used to process in person transactions.
- d) Virtual Terminal A web based virtual terminal that provides live operators the ability to process Customer payments over the telephone.

e) Mobile Text (SMS) Bill Pay and EBilling – A service that allows Clients' Customers the ability to view their balance due online, enroll in mobile text (SMS) billing and transmit payment to Client through mobile text (SMS).

3. PNS AGREES TO:

In consideration of the mutual promises and obligations in this Agreement, the sufficiency of which is hereby acknowledged, the parties agree as follows:

- a) Make available Visa, MasterCard, Discover and E-Check processing services to CLIENT for CLIENT's customers and;
- b) Notify CLIENT via email when payments are made to CLIENT and;
- c) Instruct its AUTHORIZED PROCESSORS to initiate a deposit of principal amount due to CLIENT into CLIENT designated bank checking account within two (2) business days for card and five (5) business days for ACH transactions (excluding holidays), and charge CLIENT or CLIENT customers a service fee as listed in PNS pricing section (17) below for all payments processed through PNS and;
- d) Grant access to PNS dashboard for managing account features like employee accounts, location details, payment transactions, scripts, etc. and;
- e) Provide a link from Client website to PNS and;
- f) Provide Training on the use of PNS and;
- g) Provide CLIENT web access to view/run Transaction and Settlement reports;

4. CLIENT AGREES THAT IT SHALL:

- Furnish PNS, its Authorized PROCESSORS and its ISO with all underwriting materials prior to approval including but not limited to a
 minimum of the most current two months bank statements, credit card processing statements (if applicable), previous years
 financials and a copy of the signers driver's license and;
- b) Confirm that you, your company, its principals and key employees have never been terminated by an ACH or credit card processor and that your company has not been placed on the Terminated CLIENT File (TMF) and;
- c) Pay all applicable setup fees before PNS service begins and any applicable Client Service fees as shown in paragraph 17 and;
- d) Use the PNS system as it was designed and intended for use and;
- e) Comply with all State, Federal, and Local laws, statutes, ordinances, the Electronic Funds Transfer Act, Regulation 'E', other current or prevailing NACHA operating rules, and card association rules (VISA/MasterCard & Discover) in the conduct of its business. These rules are available online at the respective party's websites and;
- f) Maintain a chargeback ratio of less than 1% for all card transactions;
- g) Maintain a minimum of twenty (20) transactions per month as found in terms and conditions C & D and;
- h) Guarantee unconditionally to PNS and its authorized PROCESSORS payment for any and all consumer eCheck/ACH returns and/or Credit or Debit card processing chargebacks that were previously funded by PNS to CLIENT and;
- Execute a Sub-CLIENT Agreement with Authorized PROCESSORS if your business processes over \$100,000 in Credit and/or Debit Cards within a calendar year and;
- j) CLIENT will be responsible for inserting web link on CLIENT website for navigating CLIENT customers to PNS and;
- k) CLIENT shall enter into all applicable credit card and ach processing agreements required to process payments with PNS and;
- CLIENT shall notify CLIENT customers within 60 days from the Effective Date with instructions on how to access PNS by adding a message to CLIENT business phone messaging system and by inserting instructions on CLIENT customer billing statements and;
- m) CLIENT shall notify all CLIENT customers of any transaction fees to be paid by CLIENT customers and shall be solely responsible for all such notifications to CLIENT customers.

5. TERMS AND CONDITIONS

- a) PNS agrees to provide our services to CLIENT as outlined in this Agreement and;
- b) This Agreement will begin on the Effective Date and continue for a term of 2 (two) years from the Effective Date, unless sooner terminated as provided herein below. After the 2 (two) year term, the Agreement will then automatically renew for additional 1 (one) year periods. Either party has the right to cancel immediately without notice if the either party reasonably suspects fraud, collusion, dishonesty or misrepresentation and;

- c) When CLIENT owes PNS money for any reason, PNS (through its Processors) may ACH CLIENT's checking account for all fees and/or payments due PNS, with notice. CLIENT must pay PNS on demand for this Agreement and any future agreement and;
- d) A minimum of twenty (20) transactions per monthly billing cycle must be met by the CLIENT. If this minimum transaction limit is not met, a flat charge of \$50 will be electronically debited from CLIENT's bank account by PNS for any CLIENT not meeting the minimum transaction limit and;
- e) A consumer may Chargeback, some or all of a Payment Transaction. If the Consumer only issues a Chargeback for the Service Fee the Client will be responsible to PNS for the Service Fee. If a consumer issues a complete Chargeback including both the Principle Amount and Service Fee both a \$35 Chargeback fee and the original Principle Payment Transaction amount will be debited by ACH from the same account that the funds were deposited into. If an ACH debit returns for any reason by CLIENT's bank, a \$39 fee per occurrence will apply and;
- f) CLIENT acknowledges that all Payment Transactions and credits provided to CLIENT are provisional and subject to suspension, to Chargebacks and to Adjustments in accordance with this Agreement. Without limiting Authorized Processor or PNS remedies, Authorized Processors or PNS may obtain the amount due by deducting it from the Settlement Account, Reserve Account or other accounts of or funds due CLIENT.
- g) If PNS or CLIENT terminates this Agreement, then PNS retains access to CLIENT bank account for 365 days from the time of termination to process chargebacks as per NACHA and Card Association rules and;
- h) All users of PNS must follow PNS's Privacy Policy which may change with or without notice, the terms of which are incorporated by references as if fully set forth herein and found on the PNS website and;
- i) An investigative or Consumer Report may be made in connection with the application. Applicants authorize PNS or its BANK or/and any credit bureau or credit reporting agency employed by PNS and/or agents of PNS to investigate references, statements or data obtained from the CLIENT or any of the principals, officers, employees or agents for the purpose of this application and Agreement and will be used to determine the financial condition of the CLIENT and;
- j) The consumer service fee pricing is based on information provided to PNS from CLIENT as well as the processing cost from Authorized PROCESSORS. PNS reserves the right to adjust pricing if the information provided by CLIENT is not accurate or changes over time and/or in the event the Authorized PROCESSORS increase processing costs to PNS.

6. CORPORATE GUARANTY

FOR VALUE RECEIVED, the undersigned corporation CLIENT guarantees unconditionally to PNS, and its Authorized PROCESSORS, as the case may be, payment at maturity or upon demand of any and all indebtedness obligations, whether direct or indirect, absolute or contingent, primary or secondary, joint or several, and any and all renewals, extensions, restructuring, continuations, consolidations and increases thereof for which PNS or Authorized PROCESSORS now or hereafter may become liable or indebted as a result of PNS processing credit card and ACH payments on behalf of CLIENT, whether arising by contract, chargebacks of credit card items, notes, drafts, overdrafts, discount, under law or in equity or otherwise (hereinafter collectively referred to as the "Guaranteed Indebtedness").

In the event of payments due by PNS or PROCESSORS in the payment or performance of all or any portion of the Guaranteed Indebtedness, when such Guaranteed Indebtedness becomes due, either by its terms or as the result of the exercise of any power to accelerate, CLIENT shall, on demand and without further notice of dishonor, pay the full amount due thereon to PNS at its office in Tennessee. CLIENT hereby waives notice of acceptance of this Guaranty, notice of default to CLIENT and waives all other notices in connection herewith or in connection with the Guaranteed Indebtedness, and further waives diligence, presentment, protest, and suit on the part of PNS or PROCESSORS in the collection of any of the Guaranteed Indebtedness or to foreclose, proceed against, or exhaust any collateral or security for any Guaranteed Indebtedness (or to represent any item that is the subject of any chargeback), before requiring CLIENT to pay the full amount of the liability hereby created. Suit may be brought and maintained against CLIENT at the election of PNS or PROCESSORS without joinder of the Debtor or any other guarantors. CLIENT shall pay PNS and authorized PROCESSORS reasonable collection and attorneys' fees incurred in PNS's effort to collect the Guaranteed Indebtedness from Client. Demand hereunder shall be deemed to have been made when in person or mailed postage prepaid to CLIENTS's address as hereinafter set forth.

This Guaranty is a continuing guaranty and it shall continue to apply without regard to the form or amount of Guaranteed Indebtedness that the Client (with or without notice to CIENT) may create, incur, renew, extend or alter, in whole or in part. CLIENTS's liability hereunder shall not be affected by any surrender, release, exchange or alteration of any collateral or security for any Guaranteed Indebtedness or any release, settlement, payment (partial or in full) or other agreement with the Client or other person or entity relating to the Guaranteed Indebtedness. The rights of PNS and Authorized PROCESSORS hereunder shall be cumulative. The exercise by PNS or PROCESSORS of any right or remedy hereunder or under any other instrument, or at law or in equity, shall not preclude

concurrent or subsequent exercise of any right or remedy. This Guaranty is performable for all purposes in Rutherford County, TN, and CLIENT waives the right to sue or be sued elsewhere.

Notwithstanding any other provision of this Guaranty, PNS, PROCESSORS and CLIENT agree that Guarantor shall never be required to pay interest in excess of the maximum interest rate permitted by law. Any contract for interest shall be subject to reduction to the maximum interest rate allowed under law.

This Guaranty shall be governed by and construed in accordance with the laws of the State of Tennessee.

7. PERSONAL GUARANTEE

In the event that the CLIENT Fails to make any payments to PNS, or PROCESSORS, as the case may be, including the failure to pay any Guaranteed Indebtedness or fails to perform in any manner under this Agreement, the Guarantor signed below does hereby promise to make all payments to PNS or PROCESSORS, as the case may be, in the same manner as if they were the party named in this Agreement. This is a guarantee of payment and not collection and the undersigned also guarantees to PNS payment of all cost of collection to enforce this guarantee including PNS or PROCESSORS' legal fees.

8. REPRESENTATIONS AND WARRANTIES

THE WEB SITE SERVICES ARE PROVIDED TO CLIENT ON AN "AS IS" "AS AVAILABLE" BASIS WITHOUT WARRANTY OF ANY KIND EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF CLIENTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT, PNS, AND/OR PROCESSORS MAKE NO WARRANTY AS TO THE ACCURACY, COMPLETENESS, CURRENCY, OR RELIABILITY OF ANY CONTENT AVAILABLE THROUGH THE WEB SERVICE. CLIENT IS RESPONSIBLE FOR VERIFIYING ANY INFORMATION BEFORE RELYING ON IT. USE OF THE WEB SERVICE AND THE CONTENT ON THE WEB SERVICE IS AT THE CLIENT'S SOLE RISK. PNS AND/OR PROCESSORSMAKE NOT REPRESENTATIONS OR WARRANTIES THAT USE OF THE WEB SERVICE WILL BE UNINTERRUPTED OR ERROR-FREE.

9. LIMITATION OF LIABILITY

CLIENT releases and discharges PNS and Authorized PROCESSORS, and agrees to indemnify and hold harmless, PNS and Authorized PROCESSORS for any loss, cost, judgment, penalty, claim, action, damage, expenses or attorney's fees which may be incurred by PNS or Authorized PROCESSORS from any loss sustained by CLIENT as a result of any acts, errors, or failures to act of CLIENT, the Automated Clearing House, banks, credit or debit card processors, communications carriers or clearing houses through which entries may be originated or PNS receives or transmits information, and no such entity shall be deemed PNS or Authorized PROCESSORS agent. Further, CLIENT agrees that PNS or Authorized PROCESSORS shall have no responsibility, nor bear any loss, liability or delay caused by fires, earthquakes, wars, civil disturbances, power surges or failures, acts of government, labor disputes, terrorist attacks, failure in communication networks, legal constraints or other events beyond PNS or Authorized PROCESSORS control. No action or proceeding arising out of this Agreement may be brought by us or you more than one year after the cause of action has arisen. If at any time, CLIENT believes PNS is in breach of this Agreement, CLIENT must give an officer of PNS actual written notice and allow PNS or Authorized PROCESSORS thirty (30) days to cure the alleged breach.

10. INTELLECTUAL PROPERTY

"Intellectual Property" means all of the following owned by a party: (i) trademarks and service marks (registered and unregistered) and trade names and goodwill associated therewith; (ii) patents, patentable inventions, computer programs, and software; (iii) databases; (iv) trade secrets and the right to limit the use or disclosure thereof; (v) copyrights in all works, including software programs; and (vi) domain names. The rights owned by a party in its Intellectual Property shall be defined, collectively, as "Intellectual Property Rights." Other than the express licenses granted by this Agreement, PNS grants no right or license to CLIENT by implication, or otherwise to PNS's Products or any Intellectual Property Rights of PNS. PNS shall retain all ownership rights, title, and interest in and to its own products and services (including in the case of any PNS services provided to CLIENT) and all Intellectual Property Rights therein. CLIENT will cooperate with PNS in pursuing such protection. CLIENT acknowledges that all services provided to CLIENT by PNS, including any improvements or changes made in the Intellectual Property or services remain the Intellectual Property of PNS and CLIENT has no ownership rights.

11. MUTUAL INDEMNIFICATION AND HOLD HARMLESS

CLIENT agrees to indemnify and hold harmless PNS and Authorized PROCESSORS, its employees, officers, agents, and directors from any and all Losses, fines, penalties, claims, expenses (including attorney fees), or other liabilities resulting from or in connection with CLIENT's obligations and performance under this Agreement, or CLIENT's breach of this Agreement. PNS agrees to indemnify and hold harmless CLIENT, its employees, officers, agents, and directors from any and all Losses, fines, penalties, claims, expenses (including attorney fees), or other liabilities resulting from or in connection with PNS's obligations and performance under this Agreement, or PNS's breach of this Agreement.

12. NO MODIFICATIONS

No oral modification to this Agreement will be accepted. Any written modification must be approved in writing by an officer of PNS. PNS is not an agent or fiduciary of CLIENT or others. PNS and Authorized PROCESSORS are arm's length independent contractors. Any unenforceable clause within this Agreement will be excluded and the remainder enforced. PNS or Authorized PROCESSORS may assign this Agreement in writing. If CLIENT transfers or sells its business and the new operator or owner continues to use PNS's service, they are also bound by this Agreement. PNS may change the terms of this Agreement at any time upon reasonable notice to CLIENT.

13. ARBITRATION RESOLUTION

CLIENT agrees that any dispute or claim related this Agreement as between CLIENT and PNS will be settled by the American Arbitration Association using the commercial arbitration rules. Judgment on the award rendered may be entered in a court in Rutherford County, Tennessee. The sole site of the arbitration shall be Rutherford County, Tennessee. Tennessee law will apply. The Arbitrator may, in the Arbitrator's discretion, award the prevailing party in the arbitration up to the full amount of its reasonable costs and expenses occasioned by the arbitration. This may include, but not be limited to, attorney's fees, costs of reproduction, travel expense, and other expense as a direct result of the arbitration.

14. FORCE MAJEURE

Neither party will be responsible for delays or failures on performance resulting from acts beyond the control of such party. Such acts will include but not limited to acts of God, strikes, lockouts, riots, power outages, acts of war, terrorist attacks, epidemics, and government regulations superimposed after the fact, fire, communication line failures, earthquakes or other disasters.

15. COMPLETE AGREEMENT: AMENDMENT

This Agreement and any attached Addendums constitute the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements between the parties whether written or oral, referring to the same subject matter. Modifications, amendments, cancellations or supplements to or any other change in any term or condition of this Agreement, including any exhibits, work orders, or other attachments will be enforceable only if they are in writing and are signed by an officer of PNS. CLIENT acknowledges and agrees that PNS' ISO, and in particular Authorized PROCESSORS shall be a third party beneficiary and may enforce this Agreement against CLIENT and guarantees as Guarantors as set forth herein, notwithstanding that such ISO or Authorized PROCESSORS are not signatories hereto.

16. CONFIDENTIALITY

The Parties expressly acknowledge that the data and other information to which the Parties and their employees and agents have access in connection with the negotiation; performance and administration of this Agreement have commercial value and are proprietary to the respective Party . Each Party agrees that it will not use for its own purposes, will not disclose to any third party, and will retain in strictest confidence all information and data belonging to or relating to the business of the other (including without limitation the terms and pricing of this Agreement), and that each Party will safeguard such information and data by using the same degree of care and discretion that it uses to protect its own confidential information.
