**LEGAL NOTICE**

Notice is hereby given that Atmos Energy Corporation (the Company) filed a Petition with the Tennessee Regulatory Authority (TRA) on February 9, 2017 in Docket 17-00016, seeking approval pursuant to Tenn. Code Ann. 65-4-107 of a new franchise agreement with the City of Murfreesboro. This franchise agreement grants the Company the non-exclusive rights, authority, privilege and franchise for the distribution of natural gas and for the installation and maintenance of mains, pipes, pipelines, distribution lines, and other equipment necessary or incidental to distribution of said gas upon, across, along and under the highways, streets, avenues, roads, alleys, lanes and other public grounds of the City of Murfreesboro, Rutherford County, Tennessee in order to furnish gas service within the City to its inhabitants. A complete copy of the Company's filing is on file with the TRA and is open for public inspection. The franchise and the rights granted shall take effect upon approval of the Tennessee Regulatory Authority and shall continue in force for a term of ten (10) years. During each year of the term hereof, the Company shall collect from its customers within the City of Murfreesboro a franchise fee in an amount of 5% of Company's Revenues within the City, as defined in the agreement, and \$0.017 per one hundred cubic feet (Ccf) of natural gas transported by Atmos Energy within the City limits to each customer of Atmos Energy who has elected receive gas transportation service from Atmos Energy. Said franchise fee shall be paid quarterly to the City of Murfreesboro with each payment due and payable within thirty (30) days from the end of the quarter for which payment is due, so long as the Company shall supply and sell natural gas to the public within said City, or so long as this franchise is in effect. The matter has been set for hearing on March 13, 2017 beginning at 1:00 p.m. CST or as soon thereafter as it may be heard in the TRA's hearing room on the ground floor of the Andrew Jackson State Office Building at 500 Deaderick Street, Nashville, Tennessee.




