- 5) How does Velocity intend to comply with TCA 65-21-114, which prohibits toll charges on calls that begin and terminate in the same county?

It is requested that this information be provided no later than 2:00 pm on June 26, 2017 and that you reference Docket Number 17-00040 on the response.
