# INITIAL ORDER GRANTING CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

This matter came before the Hearing Officer of the Tennessee Public Utility Commission (the "Commission" or "TPUC") at a Hearing held on January 18, 2018 to consider the Application of Premier Satellite, LLC for a Certificate to Provide Competing Local Telecommunications Services (the "Application") filed by Premier Satellite, LLC ("Premier" or "Applicant") on June 26, 2017. In its Application, Premier seeks a Certificate of Public Convenience and Necessity ("CCN") for authority to provide competing local telecommunications services within the State of Tennessee.

## LEGAL STANDARD

Premier's *Application* was made pursuant to and considered in light of the criteria for granting a CCN as set forth in Tenn. Code Ann. § 65-4-201 which provides, in pertinent part:

(a) No public utility shall establish or begin the construction of, or operate any line, plant, or system, or route in or into a municipality or other territory already receiving a like service from another public utility, or establish service therein, without first having obtained from the commission, after written application and hearing, a certificate that the present or future public convenience and necessity require or will require such construction, establishment, and operation, and no person or corporation not at the time a public utility shall commence the

construction of any plant, line, system, or route to be operated as a public utility, or the operation of which would constitute the same, or the owner or operator thereof, a public utility as defined by law, without having first obtained, in like manner, a similar certificate ....

\* \* \*

- (c) After notice to the incumbent local exchange telephone company and other interested parties and following a hearing, the authority shall grant a certificate of convenience and necessity to a competing telecommunications service provider if after examining the evidence presented, the authority finds:
- (1) The applicant has demonstrated that it will adhere to all applicable commission policies, rules and orders; and
- (2) The applicant possesses sufficient managerial, financial, and technical abilities to provide the applied for services.

Furthermore, pursuant to Tenn. Code Ann. § 65-5-112, a competing telecommunications provider is required to file with the Commission a small and minority-owned telecommunications business participation plan which provides a plan containing the provider's plan for purchasing goods and services from small and minority-owned telecommunications businesses and information on programs that might provide technical assistance to such businesses.

## **HEARING ON THE MERITS**

Pursuant to Tenn. Code Ann. § 65-4-204, public notice of the Hearing in this matter was issued by the Hearing Officer on January 5, 2018. No persons sought intervention prior to or during the Hearing. Mr. Thomas Stevens, managing member of Premier Satellite, LLC, appeared at the Hearing and provided testimony.

Mr. Stevens participated in the Hearing, adopted and summarized his pre-filed testimony and was subject to examination by the Hearing Officer. During the Hearing, Mr. Stevens

testified that Premier is experienced in the installation of fiber networks in apartment complexes and have begun building a fiber and wireless network connecting all of the Company's properties. Further, Mr. Stevens submitted financial statements and other exhibits to the *Application* as part of the record of this matter.

The Hearing Officer opened the floor for public comment, but no member of the public came forward to comment. Upon conclusion of the presentation of its proof, the Hearing Officer granted Premier's *Application* based upon the following findings of fact and conclusions of law:

## I. PREMIER'S QUALIFICATIONS

- Premier is a limited liability company organized under the laws of the State of Tennessee, originally established on October 28, 2015 and authorized to transact business in Tennessee by the Secretary of State on said date.

- 3. The *Application* and information in the record indicate that Premier has the requisite technical and managerial ability to provide competitive access services and transport telecommunications services within the State of Tennessee. Specifically, Premier's management team possesses extensive business, technical, operational and regulatory experience.
- 4. Premier has the necessary capital and financial ability to provide the services it proposes to offer.
- Premier has represented that it will adhere to all applicable statutes, policies, rules and orders of the Commission.

#### II. PROPOSED SERVICES

Premier intends to provide local exchange, intraLATA toll and interLATA interexchange services in Tennessee. Premier is currently designing a fiber optic network and intends to connect its customer properties with fiber internet service in Shelby County, Tennessee and will be the first independent, locally-owned and managed gigabit internet service provider in West Tennessee. The Applicant currently anticipates its network will pass 3,000 homes, with a third of those being current bulk satellite video and internet customers. Premier has provided broadband internet services since 2012.<sup>1</sup>

#### III. PERMITTING COMPETITION TO SERVE THE PUBLIC CONVENIENCE AND NECESSITY

Premier's *Application* and its proposed services would inure to the benefit of the present and future public convenience by permitting competition in the telecommunications services markets in the State and fostering the development of an efficient, technologically advanced statewide system of telecommunications services.

# IV. SMALL AND MINORITY-OWNED TELECOMMUNICATIONS BUSINESS PARTICIPATION PLAN AND BUSINESS ASSISTANCE PROGRAM

Premier has filed a satisfactory small and minority-owned telecommunications business participation plan, pursuant to Tenn. Code Ann. § 65-5-112 and the Commission's Rules.

#### IT IS THEREFORE ORDERED THAT:

- 1. The Application of Premier Satellite, LLC for a Certificate to Provide Competing Local Telecommunications Services is approved.
- 2. Any party aggrieved by the Hearing Officer's decision in this matter may file a petition for reconsideration within fifteen days from the date of this Order.
