#### PETITION FOR EXPEDITED REVIEW OF CENTRAL OFFICE CODE DENIAL

Concord Telephone Exchange, Inc. ("Concord"), pursuant to rules adopted by the FCC for challenging determinations of the Number Pooling Administrator ("NeuStar"), petitions the Tennessee Public Utility Commission (the "Commission") for an expedited review of NeuStar's denial of Concord's application for 3,000 consecutive numbers in the 865-672 NPA / NNX code.

Concord respectfully shows the Commission as follows:

- Concord is a market regulated public utility providing broadband, IPTV and voice services in the Concord Rate Center.
- 2. NeuStar is an independent non-governmental entity that is responsible for administering and managing the North American Numbering Plan ("NANP"). See C.F.R. § 52.13(a), (b).
- 3. On March 31, 2000, the Federal Communications Commission issued a Report and Order and Further Notice of Proposed Rule Making relating to numbering resource optimization ("FCC 00-104" or the "March Order"). On December 29, 2000, the FCC issued its Second Report and Order, Order on Reconsideration in CC Docket No. 96-98 and CC Docket No. 99-200, and Second Further Notice of Proposed Rulemaking in CC Docket No. 99-200 ("FCC 00-429" or the

- "December Order"). These FCC orders addressed issues and strategies relating to the efficient use of numbering resources.
- 4. In FCC 00-104 and FCC 00-429, the FCC announced rules and sought comments in an effort to implement uniform standards governing requests for telephone numbering resources in order to increase efficiency in the use of existing telephone numbers and to slow further exhaustion of existing numbers under the NANP.
- 5. Among other things, FCC 00-104 adopted a revised standard for assessing a carrier's need for numbering resources by requiring carriers to report rate center based utilization data to NeuStar. The FCC further required that to qualify for access to new numbering resources, applicants must establish that existing inventory within the applicant's rate center will be exhausted within six months of the application. Prior to this ruling, the Central Office Code Assignment Guidelines, used by the industry and NeuStar to make code assignments, required the applicant's existing number inventory within the applicant's serving switch to exhaust within six months of the code application in order for a code to be assigned.
- 6. This shift to a "rate center" basis for determining the need for new numbering resources was intended to "more accurately reflect how numbering resources are assigned" and to allow "carriers to obtain numbering resources in response to specific customer demands." FCC Order ¶ 105. On December 28, 2001, the FCC entered an order retaining the rules requiring carriers to calculate MTE on a rate center basis rather than on a per-switch basis. *In the Matter of Numbering*

- Resource Optimization; Implementation of the Local Competition Provisions of the Telecommunications Act of 1996; Telephone Number Portability, CC Docket Nos. 99-200, 96-98 and 95-116, Third Report and Order and Second Order on Reconsideration in CC Docket No. 99-200, FCC 01-362, Paragraph 48 (rel. Dec. 28, 2001).
- 7. On July 14, 2017 Concord submitted a Central Office Code (NXX) Assignment Request Part 1, and the CO Code Assignment Months to Exhaust Certification Worksheet, to NeuStar to be assigned an 865 Code for the Concord Rate Center. The request and worksheet are attached hereto as Exhibit "A". The code request is for 3,000 consecutive numbers to be used by Tennova Healthcare.
- 8. The code assignment request is to obtain 3,000 consecutive numbers in the 865-672 code for Concord's Metaswitch CNCRTNXADS2.
- 9. The Code assignment request is based on Tennova Healthcare need for 3,000 consecutive numbers in the same NPA / NXX. (Exhibit D). Concord does not have 3,000 consecutive numbers in its inventory to meet the needs of this customer. Concord needs to request three thousand-blocks from pooling that TDS originally donated to the pool and where TDS is the code holder (865-672 NPA/NXX).
- 10. Concord will be assigning all 3,000 numbers obtained to Tennova Healthcare to replace their current outdated system at their Turkey Creek Medical Center location. Once the transition to the new numbers is complete, Tennova Healthcare will be relinquishing the majority of their existing numbers that are spread across multiple NXXs to Concord for redeployment to other customers.

- Concord completed the applications in accordance with NeuStar's Central Office
   Code (NXX) Assignment Guidelines and completed the necessary Months to
   Exhaust Certification Worksheet required by NeuStar.
- 12. At the time of the code request, the Concord Rate Center had a month to exhaust of approximately 68.96 months. (Exhibit B)
- 13. Despite the fact that Concord's Rate Center may not exhaust for 68.96 months, Concord is unable to provide 3,000 consecutive numbers in the 672 code.
- 14. On July 14, 2014, NeuStar's Central Office Code Administration denied the code assignment requests on the grounds that Concord had not met the months-to-exhaust and utilization criteria set forth in the Central Office Code (NXX) (Exhibit C)
- 15. Concord's inability to meet Tennova's Healthcare needs without the requested numbers impact's Tennova's efforts to improve healthcare services in the Concord / Farragut area.
- 16. Both FCC 00-104 and NeuStar's Central Office Code (NXX) Guidelines provide that state regulatory authorities have the power and authority to review NeuStar's decision to deny a request for numbering resources. See FCC 00-104, Appendix A, Final Rules, § 52.15(g) (3) (iv) ("The carrier may challenge the NeuStar's decision to the appropriate state regulatory commission"); NeuStar Central Office Code (NXX) Guidelines § 13.0 ("Appeals may include but are not limited to one or more of the following options: . . . C. The CO Code Administrator(s) and code holders/applicants may pursue the disagreement with the appropriate governmental/regulatory body").

- 17. The Commission has recognized its jurisdiction and authority to review NeuStar denials and to order the release of numbering resources to meet specific customer needs.
- 18. In reviewing previous petitions of this type, the Commission Staff has requested that parties provide additional information concerning number utilization for the specific central office involved in the request. This information for the Concord Rate Center is attached hereto as Exhibit "B."
- 19. The Commission, and not the FCC, is the most appropriate body to address this appeal. As noted above, the Commission has been granted jurisdiction to hear appeals from NeuStar's decisions regarding numbering resources. Any jurisdiction of the FCC to do the same is merely concurrent with the jurisdiction of the Authority. Concord believes that the Commission can more quickly address the numbering problem facing Concord, and, because time is of the essence, Concord believes it is appropriate to pursue this matter in the forum that can most quickly address the issue.
- 20. Under earlier months-to-exhaust procedures used by NeuStar, waivers or exceptions were granted where customer hardships could be demonstrated or where the service provider's inventory did not have a block of sequential numbers large enough to meet its needs. Under existing procedures, NeuStar looks at the number of months-to-exhaust for the entire rate center without any exceptions. The current process for review is arbitrary and results in decisions contrary to the public interest. Moreover, the denial of numbering resources to Concord to meet its customers' needs is inconsistent with the FCC's position that "[u]nder no

circumstances should consumers be precluded from receiving telecommunications

services of their choice from providers of their choice for want of numbering

resources." FCC 00-429 at ¶ 61. By refusing to grant numbering resources

sufficient to meet Concord's customer - Tennova Healthcare - needs, NeuStar is

impacting Tennova's ability in providing the healthcare services to the local

Concord and Farragut communities.

**CONCLUSION** 

For the reasons articulated above, Concord Telephone Exchange, Inc. respectfully urges

the Commission to direct NeuStar to provide the requested 3,000 consecutive numbers in the

865-672 code to Concord to enable Tennova Healthcare to provide the improved healthcare

services to the Concord and Farragut communities.

WHEREFORE, Concord Telephone Exchange, Inc. requests:

1. The Commission review the decision of the NeuStar to deny Concord's request

for the 3,000 consecutive numbers in the 865-672 code; and

2. The Commission direct NeuStar to provide the requested 3,000 consecutive

numbers in the 865-672 Concord Rate Center.
