ORDER ESTABLISHING PROCEDURAL SCHEDULE

This matter is before the Hearing Officer of the Tennessee Public Utility Commission ("Commission" or "TPUC") to establish a procedural schedule for the prompt and orderly conduct of these proceedings. The goal and design of any procedural schedule is to efficiently move the proceedings forward to a hearing and final conclusion on the merits. Nevertheless, a procedural schedule's effectiveness directly depends on cooperation by the parties in meeting the individual benchmark dates.

On October 23, 2017, Kingsport Power Company d/b/a AEP Appalachian Power ("KPC") filed a *Motion for Expedited Proceedings* ("*Motion*") and *Bristol Tennessee Essential Services* ("BTES") filed a response on October 30, 2017. In its *Motion*, KPC requests that this docket be expedited "by establishing a tight schedule so as to permit this boundary dispute to be

determined as soon as practical." BTES agreed with the *Motion*.² On November 2, 2017, the parties emailed the Hearing Officer a proposed procedural schedule.

The Hearing Officer finds that it is necessary to expedite these proceedings because in January 2018, the Sullivan County School System anticipates breaking ground on the new school, which is at the heart of this boundary dispute. The Hearing Officer, therefore, determines that KPC's *Motion* should be granted and establishes a procedural schedule based on the preferences of the parties.

IT IS THEREFORE ORDERED THAT:

- 1. The *Motion for Expedited Proceedings* filed by Kingsport Power Company d/b/a AEP Appalachian Power on October 23, 2017 is granted.
- 2. The Procedural Schedule is established as set forth in **Exhibit A** attached to this Order.
