Dear Ms. Dillon:

Enclosed for filing in the above-referenced case, please find an original and thirteen copies of Kentucky Utility Company's ("KU") biweekly update. This letter will serve as the second update requested by the Tennessee Public Utility Commission ("TPUC") in the above-referenced proceedings. KU will continue to file periodic biweekly updates with the TPUC until such time as the TPUC has acted on KU's Joint Petition.

In Kentucky, the Kentucky Public Service Commission has granted motions to intervene of the Kentucky Industrial Utility Customers, Inc. and the Office of Attorney General since KU's update to the TPUC on November 10, 2017.¹ The procedural schedule provides that initial requests for information are due to the Joint Applicants on November 20, 2017; the KPSC Staff and the Attorney General filed limited requests for information by this deadline.

In Virginia, no further action has been taken by the Virginia State Corporation Commission since KU's last update to the TPUC. As KU indicated in its November 10, 2017 letter, KU believes the VSCC Staff's analysis and determination provide a satisfactory outcome. Subject to obtaining satisfactory approvals or determinations that such approvals are not required from the KPSC and the TPUC, KU expects to proceed with the reorganization as proposed.
