As you are aware, on December 15, 2017, the Commission opened a contested case and appointed you as hearing officer in the above Petition. Nolensville College Grove Utility District and my client, Milcrofton Utility District have a pending Motion to Intervene in this docket and related Motion to Dismiss. The CAD has also indicated that Mr. Powell's continued pursuit of relief in this docket without hiring an attorney is a violation of the civil and criminal laws of the State of Tennessee. Milcrofton respectfully requests that a Status Conference be had to determine the following:

- 1. Ruling on the pending Motion to Intervene;
- 2. The need for Mr. Powell to secure counsel in this matter;
- 3. Timing of Briefing of Motion to Dismiss;
- 4. Accessing the information filed under seal by all parties who are permitted to intervene.
