On November 15, 2017, BCHI Holdings, LLC, Birch Communications, Inc., Fusion Telecommunications International, Inc. and Network Billing Systems, LLC, (collectively, the "Petitioners,") submitted the above-referenced filing requesting consent to proceed with a transaction including, among other elements, participation by certain of the Petitioners in new financing up to a total of \$720 mm. Subsequent to the filing of the application, Petitioners have revised their forecasted business plans and borrowing commitments. Accordingly, they submit this amendment to increase the projected maximum financing amount to \$775 mm. The change reflects an additional facility component that will provide an accordion loan, available to New Fusion Birch for various corporate purposes including possible additional acquisitions. The rationale for the financing and its demonstrable benefits are fully described in the Petition.
