







Notice is hereby given that Atmos Energy Corporation (the Company) filed a Petition with the Tennessee Public Utility Commission (TPUC) on November 17, 2017 in Docket No. 17-00130, seeking approval pursuant to Tenn. Code Ann. § 65-4-107 of a new franchise agreement with the Town of Bluff City. This franchise agreement grants the Company the non-exclusive rights, authority, privilege and franchise to erect, construct, reconstruct, maintain and operate a natural gas plant or plants for the manufacturing and processing of any and all kinds of gas and for the distribution of natural gas and for the installation and maintenance of mains, pipes, pipelines, distribution lines, and other equipment necessary or incidental to distribution of said gas upon, across, along and under the highways, streets, avenues, roads, alleys, lanes and other public grounds of the Town. A complete copy of the Company's filing is on file with the TPUC and is open for public inspection. The franchise and the rights granted shall take effect upon approval of the Tennessee Public Utility Commission and shall continue in force for a term of twenty (20) years. There is no franchise fee associated with the franchise. The matter has been set for hearing on January 16, 2018 beginning at 1:00 p.m. CST or as soon thereafter as it may be heard in the TPUC's hearing room on the ground floor of the Andrew Jackson State Office Building at 500 Deaderick Street, Nashville, Tennessee.
