1. All consumer complaints filed or memorialized with the Commission concerning Chattanooga Gas Company since May of 2012, in either electronic format or paper, excluding any complaints posted publicly on the Commission's docket website. Please consider this request ongoing in nature for any new complaints.
2. All annual reports filed by Chattanooga Gas Company with the Commission for the last four years.

3. Pipeline safety reports filed by Chattanooga Gas Company with the Commission, other than Federal Department of Transportation reports.
4. Daily heating degree days for Chattanooga, Tennessee for the period from January 1985 through December 2017 from the TPUC's Weather Normalization Adjustment Audits.
