
PROPOSED PROCEDURAL SCHEDULE

Chattanooga Gas Company (“CGC” or “Company”) files this proposed Procedural Schedule along with its Petition for Approval of An Adjustment in Rates and Tariff; the Termination of the AUA Mechanism and the Related Tariff Changes and Revenue Deficiency Recovery; and an Annual Rate Review Mechanism for consideration in this matter by the Hearing Officer as designated by the General Counsel.
