## ORDER ESTABLISHING PROCEDURAL SCHEDULE

This matter is before the Hearing Officer of the Tennessee Public Utility Commission ("Commission" or "TPUC") to establish a procedural schedule for the orderly administration of these proceedings. At the request of the Hearing Officer, Chattanooga Gas Company ("CGC" or the "Company") and the Consumer Advocate Unit in the Financial Division of the Office of the Attorney General ("Consumer Advocate"), the parties in this matter, attempted to establish a joint proposed procedural schedule. However, the parties could not reach an agreement on certain dates within the procedural schedule.

On August 28, 2019, the Consumer Advocate filed Consumer Advocate's Proposed Procedural Schedule to Address Remaining Issues Stemming from the 2017 Tax Cuts and Jobs Act and CGC filed Chattanooga Gas Company's Proposed Procedural Schedule to Address Outstanding Issues Associated with the 2017 Tax Cuts and Jobs Act ("CGC Proposed Procedural Schedule") on August 29, 2019. The main area of disagreement between the parties centered around the Company's desire to file rebuttal testimony and post-hearing briefs regarding its contention that the 2018 tax savings should be retained by the Company.

A determination on whether the parties will file post-hearing briefs or present closing arguments during the Hearing on the merits will be made at a later date.
